Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly terminate your three children's Child Health Plus plan for non-payment of premium, effective November 1, 2017?

Did NYSOH properly determine that your children's re-enrollment in their Child Health Plus plan was effective February 1, 2018?

Procedural History

On July 6, 2017, NYSOH issued an eligibility determination notice, based on your July 5, 2017 application, stating that your three children (children) were eligible for Child Health Plus at \$9.00 per month each, effective August 1, 2017.

Also on July 6, 2017, NYSOH issued a plan enrollment notice confirming your children were enrolled in a Child Health Plus plan with a start date of August 1, 2017.

On October 25, 2017, NYSOH issued a notice stating your children's coverage would end on October 31, 2017. The notice stated this was because you asked NYSOH to end their coverage on October 24, 2017.

On November 8, 2017, you spoke to NYSOH's Account Review Unit and appealed the level of your children's Child Health Plus plan.

On November 14, 2017, NYSOH issued a plan enrollment notice confirming your children's enrollment in a Child Health Plus plan, effective November 1, 2017.

On December 20, 2017, NYSOH issued a disenrollment notice stating your children's enrollment in a Child Health Plus plan was ending November 1, 2017. The notice stated your children's coverage was ending because you did not pay your insurance bill by the payment deadline.

On January 11, 2018, NYSOH issued a plan enrollment notice based on your plan selection on January 10, 2018 stating your children's enrollment in their Child Health Plus plan was effective February 1, 2018.

On February 6, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. During your telephone hearing, you testified you are seeking that your children be re-instated in their Child Health Plus plan for \$9.00 per month each, effective November 1, 2017. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are only appealing your children's disenrollment from their Child Health Plus plan for the month of November 2017, and are seeking they be re-enrolled for a cost of \$9.00 per month each.
- 2) Your children were enrolled into a Child Health Plus plan for a cost of \$9.00 per month each, effective August 1, 2017.
- 3) Your children were disenrolled from their Child Health plus plan, effective October 31, 2017.
- 4) You testified that you became aware that your children had been disenrolled from their Child Health Plus plan in January 2018.
- 5) You testified that, when you became aware that your children had been disenrolled, you contacted NYSOH to re-enroll them.
- 6) You testified that your children were re-enrolled back into their plan by NYSOH representatives for November 2017, and you were given an [REDACTED] number which would reinstate them for that month.

- 7) According to your NYSOH account, on November 8, 2017, NYSOH representatives granted a backdate as of November 1, 2017 and sent an [REDACTED] change file to your health plan (see Incident [REDACTED]).
- 8) On January 10, 2018, NYSOH received your updated application and Child Health Plus plan selection for your children.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) an eligibility determination for an exemption; (4) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (5) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Child Health Plus

A child who meets the eligibility requirements for Child Health Plus may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (NY Public Health Law § 2511(2)(a)(iii)).

To be eligible for Child Health Plus, the child:

- Must be under 19 years of age;
- Must be a New York State Resident;
- Must not have other health insurance coverage; and
- Must not be eligible for, or enrolled in, Medicaid

(NY Public Health Law § 2511(2)(a)-(e)).

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the Child Health Plus premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health

insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly terminated your children's Child Health Plus plan for non-payment of premium, effective November 1, 2017.

On July 5, 2017, your children were enrolled in a Child Health Plus plan at \$9.00 per month each, effective August 1, 2017.

The record shows you requested their disenrollment from their health plan on October 24, 2017. As a result, their coverage ended October 31, 2017. The record further shows, on November 8, 2017, NYSOH representatives granted a backdate as of November 1, 2017 and sent an [REDACTED] change file to their health plan (see Incident [REDACTED]). This activity resulted in your children being re-enrolled in their Child Health Plus plan as of November 1, 2017.

On November 14, 2017, NYSOH issued a plan enrollment notice confirming your children's re-enrollment in their health plan as of November 1, 2017.

On December 20, 2017, NYSOH issued a notice stating that your children's Child Health Plus plan was ending November 1, 2017, because you did not pay your insurance bill by the payment deadline.

NYSOH Appeals Unit only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the

premium tax credit and level of cost-sharing reductions, (3) an eligibility determination for an exemption, (4) a failure to provide timely notice of an eligibility determination and (5) a denial of a special enrollment period.

Since the Appeals Unit is not given the authority to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether or not your children were properly terminated from their Child Health Plus plan for non-payment of premiums.

Therefore, your appeal of the December 20, 2017 disenrollment notice is **DISMISSED** as a non-appealable issue.

The second issue under review is whether NYSOH properly determined that your children's re-enrollment in their Child Health Plus plan was effective February 1, 2018.

You contacted NYSOH on January 10, 2018 to re-enroll your children into their Child Health Plus plan.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

As you contacted NYSOH to re-enroll your children into a Child Health Plus plan on January 10, 2018, their re-enrollment should have taken effect the first day of the first month after January 2018; that is, on February 1, 2018.

Therefore, the January 11, 2018 plan enrollment notice stating that your children's re-enrollment in their Child Health Plus plan was effective February 1, 2018, is **AFFIRMED**.

Decision

Your appeal of the insurer's termination of your children's enrollment in their Child Health Plus plan for non-payment of premiums, effective November 1, 2017, is **DISMISSED** as a non-appealable issue.

The January 11, 2018 plan enrollment notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

Your children's re-enrollment in their Child Health Plus plan was effective February 1, 2018.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
