Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you and your spouse were eligible to enroll in the Essential Plan, effective December 1, 2017?

Did NY State of Health properly determine that you were not eligible for Medicaid?

Procedural History

On November 10, 2017, NYSOH received an update to your application for financial assistance with health insurance. In response to this application, NYSOH prepared a preliminary eligibility determination stating that you and your spouse were eligible for the Essential Plan, effective December 1, 2017.

That same day, you contacted NYSOH's Account Review Unit and requested an appeal of that eligibility determination insofar as you and your spouse were not found eligible for Medicaid.

On November 11, 2017, NYSOH issued an eligibility determination notice based on your November 10, 2017 application. The notice stated that you and your spouse were eligible to enroll in the Essential Plan, with a \$20.00 monthly premium, effective December 1, 2017.

On February 5, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of married filing jointly, and that you will claim one dependent on that tax return.
- 2) You applied for coverage and financial assistance for yourself, your spouse, and your child.
- 3) The application that was submitted on November 10, 2017, which requested financial assistance, listed annual household income of \$31,650.00, consisting of \$30,450.00 you earn from your employment and \$1,200.00 your spouse earns. You testified that this total was correct.
- 4) You testified that you earn \$29,250.00 from your job at [REDACTED], and \$100.00 per month acting as a [REDACTED]. Your spouse also earns \$100.00 per month in the same capacity.
- 5) You will not be taking any deductions on your 2017 tax return.
- 6) You live in [REDACTED], New York.
- 7) You testified that you want you and your spouse to be determined eligible to enroll in Medicaid, instead of the Essential Plan, because the coverage is unaffordable because of the \$25.00 co-pays and the high cost of living.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income (MAGI) as defined in the federal tax code (45 CFR § 155.300(a)). The term MAGI means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were

excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

“Adjusted gross income” means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of funds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income (*id.*).

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2017 FPL, which is \$20,160.00 for a three-person household (82 Federal Register 8831).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York’s Basic Health Plan Blueprint, p. 21, as approved January 2016; see www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York’s Basic Health Plan Blueprint, as approved January 2016).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the

applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$20,420.00 for a three-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly determined that you and your spouse were eligible for the Essential Plan, effective December 1, 2017.

The application that was submitted on November 10, 2017 listed an annual household income of \$31,650.00, and the eligibility determination relied upon that information. You testified this amount was correct.

You asked that the high cost of living in your county be considered when calculating your annual household income. However, because the Internal Revenue Service rules do not allow living to be deducted from the calculation of your adjusted gross income, they cannot be deducted when NYSOH computes your modified adjusted gross income. Therefore, NYSOH correctly determined eligibility based on annual household income of \$31,650.00.

You and your spouse are in a three-person household. You expect to file your 2017 income tax returns as married filing jointly and will claim one dependent.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household MAGI that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$20,420.00 for a three-person household. Because an annual household income of \$31,650.00 is 155.00% of the 2017 FPL, NYSOH properly found you to be eligible for the Essential Plan, with a \$20.00 monthly premium.

The second issue under review is whether NYSOH properly determined that you and your spouse were not eligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable

family size. On the date of your application, the relevant FPL was \$20,420.00 for a three-person household. Since \$31,650.00 is 155.00% of the 2017 FPL, NYSOH properly found you to be not eligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

There is no evidence in your account to show that income for you and your spouse varies from month to month. Therefore, dividing your annual income by 12, your monthly earnings would be \$2,637.50.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the applicable FPL, which is \$1,701.67 per month. Therefore, NYSOH properly found that you and your spouse did not qualify for Medicaid based on monthly income as of the date of your application.

Since the November 11, 2017 eligibility determination properly stated that, based on the information you provided, you and your spouse were eligible for the Essential Plan and not eligible for Medicaid, it was correct and is AFFIRMED.

Decision

The November 11, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You and your spouse remain eligible for the Essential Plan, effective December 1, 2017.

You and your spouse are not eligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your

request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
