Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a qualified health plan was effective September 1, 2017?

Procedural History

On September 20, 2017, NYSOH received your application for health insurance.

On September 30, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to purchase a qualified health plan at full cost, effective November 1, 2017. It further stated that you must confirm your health plan selection by October 30, 2017.

On October 18, 2017, you selected a qualified health plan for enrollment.

On October 19, 2017, NYSOH issued an enrollment notice confirming your enrollment in a bronze level health plan, effective September 1, 2017.

On November 10, 2017, you spoke to NYSOH's Account Review Unit and appealed insofar as your qualified health plan started as of September 1, 2017, and not November 1, 2017.

On January 5, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing the start date of your enrollment in your bronze level health plan.
- 2) On September 20, 2017, you submitted an application for health insurance.
- 3) On October 18, 2017, you enrolled in a health plan.
- 4) You testified that you believed that your enrollment start date would be November 1, 2017, the same date that your eligibility started as indicated in the eligibility determination notice you received dated September 30, 2017.
- 5) Your application dated September 20, 2017, states that your prior health coverage ended August 31, 2017.
- 6) You testified that you lost your health insurance through your employer in August, but that you purchased health coverage through COBRA, which ended in October 2017.
- 7) You testified that you did not know you owed a premium payment to your health plan for the months of September 2017 and October 2017 until November 2017 when your qualified health plan sent you a notice.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a qualified health plan and enrollees may change qualified health plans (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2017, the annual open enrollment period began on November 1, 2016, and extended through January 31, 2017 (45 CFR § 155.410(e)(2)).

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective

the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Special Effective Dates

If a consumer loses coverage as a result of losing minimum essential coverage and the consumer selects a plan on or before the day of the triggering event, the exchange must ensure that the coverage effective date is on the first day of the month following the date of the triggering event. If the plan selection is made after the date of the triggering event, the exchange must ensure that coverage is effective in accordance with the regular effective dates for qualified health plans (45 CFR § 155.420(2)(iv)).

Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:
 - (i) Loses minimum essential coverage.
 - (ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.
 - (iii) Loses pregnancy-related coverage.
 - (iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.
- (2)(i) The qualified individual gains a dependent or becomes a dependent through marriage, birth, adoption, placement for adoption, or placement in foster care, or through a child support order or other court order.
 - (ii) the enrollee loses a dependent or is no longer considered a dependent through divorce or legal separation as defined by State law in the State in which the divorce or legal separation occurs, or if the enrollee, or his or her dependent, dies.

- (3) The qualified individual, or his or her dependent, becomes newly eligible for enrollment in a qualified health plan because he or she gains citizenship, status as a national, or lawful present or is no longer incarcerated.
- (4) The qualified individual's or his or her dependent's, enrollment or nonenrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.
- (5) The enrollee or, his or her dependent adequately demonstrates to NYSOH that the qualified health plan in which he or she is enrolled substantially violated a material provision of its contract in relation to the enrollee;
- (6) The enrollee or enrollee's dependent is newly eligible or ineligible for advance payments of the premium tax credit, or change in eligibility for cost-sharing reductions.
- (7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—
 - (i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or
 - (ii) Was living outside of the United States or in a United States territory at the time of the permanent move;
- (8) The qualified individual or dependent who gains or maintains status as an Indian may enroll in a qualified health plan or change from one plan to another, once per month.
- (9) The qualified individual or enrollee, or his or her dependent, demonstrates to the Exchange, in accordance with guidelines issued by HHS, that the individual meets other exceptional circumstances as the Exchange may provide;
- (10) A qualified individual or enrollee—
 - (i) Is a victim of domestic abuse or spousal abandonment, including a dependent or unmarried victim within a household, is enrolled in

minimum essential coverage and seeks to enroll in coverage separate from the perpetrator of the abuse or abandonment; or

- (ii) Is a dependent of a victim of domestic abuse or spousal abandonment, on the same application as the victim, may enroll in coverage at the same time as the victim;
- (11) A qualified individual or dependent—
 - (i) Applies for coverage through NYSOH during the annual open enrollment period or due to a qualifying event, is assessed as potentially eligible for Medicaid or Child Health Plus and is determined ineligible for Medicaid or Child Health Plus either after open enrollment has ended or more than 60 days after the qualifying event; or
 - (ii) Applies for coverage at their Local Department of Social Services or Human Resources Administration during the annual open enrollment period, and is determined ineligible for Medicaid or Child Health Plus after open enrollment has ended;
- (12) The qualified individual or enrollee, or his or her dependent, adequately demonstrates to NYSOH that a material error related to plan benefits, service area, or premium influenced the qualified individual's or enrollee's decision to purchase a qualified health plan; or
- (13) At the option of NYSOH, the qualified individual provides satisfactory documentary evidence to verify his or her eligibility for an insurance affordability program or enrollment following termination of enrollment due to a failure to verify such status within 90 days.

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in a qualified health plan, was effective September 1, 2017.

On October 18, 2017, you updated the information in your NYSOH account and submitted a request to enroll in a qualified health plan. On October 19, 2017,

NYSOH issued an enrollment confirmation notice stating that your enrollment in your qualified health plan was effective September 1, 2017.

Generally, the date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including fifteenth day of a month goes into effect on the first day of the following month. A plan that is after the fifteenth day of a month goes into effect on the first day of the second following month.

Special effective dates are sometimes allowed when an individual is granted a special enrollment to enroll in plans outside of the open enrollment period.

NYSOH provided an open enrollment period from November 1, 2016 until January 31, 2017. Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period in order to enroll in, or change to another health plan offered in NYSOH. In order to qualify for a special enrollment period, a person must experience a triggering event.

Your application on September 20, 2017 indicated you lost your prior health insurance through your employer on August 31, 2017. This is considered a triggering life event which allowed NYSOH to grant you a special enrollment period.

You testified that on October 18, 2017, when you selected a health plan online, you believed your health plan would start on November 1, 2017, the same date listed in your notice of eligibility determination issued by NYSOH on September 30, 2017.

If a consumer loses coverage as a result of losing minimum essential coverage and the consumer selects a plan on or before the day of the triggering event, NYSOH must ensure that the coverage effective date is on the first day of the month following the date of the triggering event. If the plan selection is made after the date of the triggering event, the exchange must ensure that coverage is effective in accordance with the regular effective dates for qualified health plans.

NYSOH allowed you to select a plan which would coincide with the loss of your employer sponsored insurance the first day of the month after that event which would be September 1, 2017. However, during the hearing you testified that you had COBRA in the months of September and October 2017.

Therefore, the start date of your qualified health plan should have been November 1, 2017 since you lost minimum essential coverage in October 2017 and selected a qualified health plan prior to the loss of that coverage.

Accordingly, the October 19, 2017 enrollment confirmation notice is MODIFIED to state that your enrollment in your qualified health plan was effective November 1, 2017.

Decision

The October 19, 2017 enrollment confirmation notice is MODIFIED to state that your enrollment in your qualified health plan was effective November 1, 2017.

Your case is RETURNED to NYSOH to enroll you into your qualified health plan as of November 1, 2017.

Effective Date of this Decision: January 11, 2018

How this Decision Affects Your Eligibility

Your enrollment in your qualified health plan should have begun as of November 1, 2017.

Your case is being sent back to NYSOH to enroll you into coverage as of November 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
