## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On October 26, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your son was not eligible for Medicaid because the household income you provided of \$35,128.00 was over the allowable income limit of \$22,412.00. The notice further stated your son was ineligible for the Essential Plan, advance payments of the premium tax credit and cost sharing reductions, and ineligible to purchase a qualified health plan at full cost, effective November 1, 2017. The notice stated this was because verification documents showed your son was not lawfully present. You appealed this determination.

On January 4, 2018, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your son recently reapplied with NYSOH and was found eligible for health insurance coverage.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

## **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
