## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly enroll you and your spouse in an Essential Plan and your children in a Child Health Plus plan with enrollment start dates of December 1, 2017?

## Procedural History

On November 13, 2017, you submitted an application for financial assistance through NYSOH.

On November 14, 2017, NYSOH issued an eligibility determination notice stating that you and your spouse were eligible to enroll in the Essential Plan with a \$20.00 premium per month for a limited time, effective December 1, 2017, and your children were determined eligible for Child Health Plus, each with a monthly premium of \$9.00, effective as of December 1, 2017.

On November 15, 2017, you spoke with NYSOH's Account Review Unit and requested an appeal relative to the enrollment start dates of your family's health insurance plans.

On November 16, 2017, NYSOH issued a plan enrollment notice confirming that as of November 13, 2017, you and your spouse were enrolled in an Essential Plan and your children were enrolled in a Child Health Plus plan, all with an enrollment start dates of December 1, 2017.

On January 30, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Testimony was taken during the hearing and the record was fully developed and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account, you are applying for health insurance for yourself, your spouse, and three children.
- 2) According to your NYSOH account, your children were born on: [REDACTED] and [REDACTED], respectively.
- 3) You testified that your family was enrolled in health insurance through your spouse's former employer; however, that coverage ended as of September 30, 2017.
- 4) You testified that you were not informed that your family's employer-sponsored health insurance had ended until the end of October 2017.
- 5) According to your NYSOH account, on November 13, 2017, you and your spouse were enrolled in an Essential Plan.
- 6) According to your NYSOH account, on November 13, 2017, your children were enrolled in a Child Health Plus plan.
- 7) You testified that you have outstanding medical expenses for the months of October 2017 and November 2017, and want your family's health plans to be backdated to cover those medical expenses.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan - Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved

January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

### Child Health Plus – Effective Date

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

## **Legal Analysis**

Initially, it is noted that you testified you were not informed that your family’s employer-sponsored health insurance had ended until the end of October 2017. Since that is an issue outside the jurisdiction of NYSOH’s Appeals Unit, it will not be addressed herein.

The issue under review is whether NYSOH properly enrolled you and your spouse in an Essential Plan and enrolled your children in a Child Health Plus plan with enrollment start dates of December 1, 2017.

The record reflects that on November 13, 2017, you submitted an application for financial assistance through NYSOH. Based on that application, you and your spouse were determined eligible to enroll in the Essential Plan, and your children were determined eligible to enroll in Child Health Plus.

The date on which enrollment in an Essential Plan or Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

The record reflects that you selected the Essential Plan and Child Health Plus plans on November 13, 2017. Since the health plans were selected on November 13, 2017, they properly began on the first day of following month; that is as of December 1, 2017.

Therefore, the November 16, 2017 plan enrollment notice is AFFIRMED.

## **Decision**

The November 16, 2017 plan enrollment notice is AFFIRMED.

You and your spouse were properly enrolled in an Essential Plan with an enrollment start date of December 1, 2017.

Your children were properly enrolled in a Child Health Plus plan with an enrollment start date of December 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
