Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your Essential Plan coverage began, effective December 1, 2017?

Procedural History

On September 27, 2017, NYSOH redetermined your eligibility for financial assistance with health insurance.

On September 28, 2017, NYSOH issued an enrollment notice confirming your enrollment in a bronze-level QHP, with such coverage beginning July 1, 2017, at full cost of \$395.89 per month.

On October 1, 2017, NYSOH issued an eligibility determination notice stating that you were newly eligible to purchase a QHP at full cost, effective November 1, 2017.

On October 23, 2017, NYSOH received an update to your application for financial assistance with health insurance.

On October 24, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan with a \$20.00 premium per month for a limited time. This determination effective as of December 1, 2017.

Also on October 24, 2017, NYSOH issued an enrollment notice confirming your selection of an Essential Plan as of October 23, 2017, with such coverage to begin effective December 1, 2017.

On October 25, 2017, NYSOH issued a disenrollment notice confirming that your bronze-level QHP coverage would end effective November 30, 2017.

On October 26, 2017, NYSOH redetermined your eligibility for health insurance.

On October 27, 2017, NYSOH issued a notice stating that you were no longer eligible for health insurance through NYSOH because you a notice issued to you had been returned to NYSOH as undeliverable.

On November 3, 2017, NYSOH redetermined your eligibility for health insurance.

On November 4, 2017, NYSOH issued an eligibility determination notice stating that your Essential Plan coverage with a \$20.00 monthly premium would begin effective December 1, 2017.

On November 16, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential insofar as it did not begin October 1, 2017.

On January 31, 2018 you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open until February 5, 2018 to provide additional documentation. No additional documentation was received by NYSOH Appeals Unit by February 5, 2018.

Accordingly, the record was closed on February 5, 2018.

Findings of Fact

A review of the record support the following findings of fact:

- 1) NYSOH records reflects that your enrollment in the bronze-level QHP ended, effective November 30, 2017.
- 2) You submitted an application to NYSOH for financial assistance on October 23, 2017.
- 3) You testified, and the record reflects, that you enrolled in an Essential Plan on October 23, 2017.
- 4) Your enrollment in your Essential Plan was initially cancelled due to a returned mailing on October 26, 2017.

- 5) You submitted a revised application on November 3, 2017, and NYSOH redetermined your eligibility for financial assistance on that same date.
- 6) On November 3, 2017, you were found eligible to enroll in the Essential Plan, effective December 1, 2017.
- 7) You selected an Essential Plan on November 3, 2017.
- 8) You testified that you wanted your enrollment in an Essential Plan to begin on October 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your Essential Plan coverage began, effective December 1, 2017.

You testified, and your NYSOH account indicates, that you submitted your updated NYSOH application on October 23, 2017. As a result, you were found eligible for the Essential Plan as of October 23, 2017 and enrolled into a plan that day.

However, your coverage under the Essential Plan was subsequently cancelled because of a returned mailing. Your NYSOH account reflects that your eligibility was redetermined shortly thereafter on November 3, 2017, and you were found eligible to enroll in an Essential Plan. You selected an Essential Plan for coverage that same day.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On October 23, 2017, and again on November 3, 2017, you selected an Essential Plan, so your enrollment properly took effect on December 1, 2017

Therefore, the November 4, 2017 enrollment notice stating that your enrollment in the Essential Plan was effective December 1, 2017, is correct and must be AFFIRMED.

Decision

The November 4, 2017 enrollment notice is AFFIRMED.

Effective Date of this Decision: March 13, 2018

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Essential Plan is December 1, 2017.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
