## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly disenroll your child from his Child Health Plus plan for non-payment of premium, effective September 30, 2017?

Did NY State of Health properly determine that your child's enrollment in his Child Health Plus plan was effective December 1, 2017?

## Procedural History

On December 17, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination stating your child was eligible for Child Health Plus at \$9.00 per month, effective January 1, 2017.

On December 17, 2016, NYSOH issued a plan enrollment notice stating your child was enrolled in a Child Health Plus plan with an enrollment start date of January 1, 2017.

On October 9, 2017, NYSOH issued a disenrollment notice stating your child's coverage was ending September 30, 2017. The notice stated his coverage was ending because you did not pay your insurance bill by the payment deadline.

On November 7, 2017, NYSOH received your child's updated application for financial assistance.

On November 8, 2017, NYSOH issued an eligibility determination notice based on your November 7, 2017 application, stating your child was eligible for Child Health Plus at \$9.00 per month for a limited time, effective December 1, 2017. The notice directed you to provide proof of your household income by January 6, 2018.

On November 8, 2017, NYSOH issued a plan enrollment notice confirming your child's enrollment in a Child Health Plus plan with an enrollment start date of December 1, 2017.

On November 16, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's Child Health Plus plan insofar as it did not begin November 1, 2017.

On January 11, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your child's re-enrollment start date into his Child Health Plus plan.
- 2) According to your NYSOH account, your child was disenrolled for non-payment of premium effective September 30, 2017.
- 3) According to your NYSOH account, you submitted an updated application to NYSOH for financial assistance on November 7, 2017.
- 4) According to your NYSOH account and your testimony, you enrolled your child into a Child Health Plus plan on November 7, 2017.
- 5) You testified that you need your child's Child Health Plus plan to begin on November 1, 2017, because your child has medical bills that month.
- 6) You and your child reside in Bronx County, NY.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) an eligibility determination for an exemption; (4) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (5) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

### Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage" (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

## **Legal Analysis**

The first issue under review is whether NYSOH properly terminated your child's enrollment in his Child Health Plus plan for non-payment of premium effective, September 30, 2017.

Your child was enrolled in a Child Health Plus plan with an effective date of January 1, 2017.

On October 9, 2017 NYSOH issued a disenrollment notice stating your child was disenrolled from his Child Health Plus plan for non-payment of premiums, effective September 30, 2017. The notice stated this was because you did not pay your insurance bill by the payment deadline.

NYSOH Appeals Unit only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) an eligibility determination for an exemption, (4) a failure to provide timely notice of an eligibility determination and (5) a denial of a special enrollment period.

Since the Appeals Unit is not given the authority to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether or not your child was properly terminated from his Child Health Plus plan for non-payment of premiums. Therefore, your appeal of the October 9, 2017 disenrollment notice is DISMISSED as a non-appealable issue.

The second issue under review is whether NYSOH properly determined that your child's enrollment in his Child Health Plus plan was effective December 1, 2017.

You testified and the record shows that you contacted NYSOH on November 7, 2017, and enrolled your child into a Child Health Plus plan.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you enrolled your child on November 7, 2017, his plan would properly take effect on the first day of month following November 2017, that is on December 1, 2017.

Therefore, the November 8, 2017 plan enrollment notice confirming your child's enrollment in his Child Health Plus plan, effective December 1, 2017, is correct and must be AFFIRMED.

## **Decision**

Your appeal of the October 9, 2017 disenrollment notice is **DISMISSED** as a non-appealable issue.

The November 8, 2017 plan enrollment notice is **AFFIRMED**.

## **How this Decision Affects Your Eligibility**

The effective date of your child's Child Health Plus plan is December 1, 2017.

Your child did not have health insurance coverage through NYSOH for the months of October 2017 and November 2017.

## **If You Disagree with this Decision (Appeal Rights)**

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
