Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine you were not eligible to receive advance payments of the premium tax credit (APTC), effective January 1, 2018?

Procedural History

You last updated your application for financial assistance and health insurance on December 2, 2016.

On December 3, 2016, NYSOH issued an eligibility determination notice stating that you were eligible to receive up to \$139.00 in APTC, effective January 1, 2017. That notice also stated that you were not eligible for cost-sharing reductions, the Essential Plan, or Medicaid, because your annual household income was over the allowable income limits for those programs. You were subsequently enrolled in a plan.

On October 28, 2017, NYSOH issued a renewal notice, stating that for the upcoming coverage year, you were eligible to enroll in a qualified health plan (QHP) at full cost, effective January 1, 2018. This finding was made based on annual household income of \$48,240.00, which was over the allowable limits for financial assistance programs. The notice also gave instructions for what to do if you wanted to make changes to your application, or if you thought NYSOH made a mistake about your eligibility.

On November 16, 2017, you spoke to NYSOH's Account Review Unit and appealed this notice of eligibility determination insofar as you were not eligible for financial assistance.

On November 22, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to receive continuing APTC for a limited time. This was because your request for "Aid to Continue" was granted, pending the outcome of your appeal.

Also on November 22, 2017, NYSOH issued a notice of enrollment confirmation, confirming your enrollment in a QHP, beginning January 1, 2018 and with APTC of \$192.00 applied for a limited time, pending the outcome of your appeal.

On February 1, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) At your hearing you testified that your address had changed to
- 2) Apart from system generated changes, you have not updated your account since December 2, 2016, either personally or through an agent.
- 3) You testified that you expect to file your tax return for 2018 with a tax filing status of single. You will claim no dependents on that tax return.
- 4) You testified and your application reflects that you will not be taking any deductions on your 2018 tax return.
- 5) The decision issued on October 28, 2017 relied on an annual household income of \$48,240.00; there is no indication in your account as to how NYSOH arrived at this income. You testified that you earn \$49,000.00 annually, and that you are paid a gross amount of \$1,920.00 biweekly. There are no pre-tax deductions from your pay. You have only one job and no other sources of income. You expect your pay to be the same in 2018 as it was in 2017.
- 6) Your application states that you live in Westchester County.

7) You testified that you cannot afford a full premium for health insurance, because of financial obligations, including housing, utilities, car expenses, and food.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan and (1) expects to have a household income from 138% up to 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a qualified health plan, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 26 CFR § 1.36B-2, 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

 the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2018 is set by federal law at 2.01% to 9.56% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3, IRS Rev. Proc. 2017-36).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Federal Register 8831).

For annual household income in the range of at least 250% but less than 300% of the 2017 FPL, the expected contribution is between 8.10% and 9.56% of the

household income (26 CFR § 1.36B-3(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2017-36).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term "modified adjusted gross income" means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

"Adjusted gross income" means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of finds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income (*id.*).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were not eligible to receive APTC, effective January 1, 2018.

The decision issued on October 28, 2017 relied on an annual household income of \$48,240.00. You testified that you earn \$49,000.00 annually, and that you are paid a gross amount of \$1,920.00 biweekly. There are no pre-tax deductions from your pay.

It is noted that \$1,920.00 income biweekly equates to an annual income of \$49,920.00. Both this amount, and the annual salary of \$49,000.00 you testified to, are greater than the income used in NYSOH's determination regarding your eligibility for financial assistance. Because there has been no explanation as to how NYSOH arrived at annual expected household earnings of \$48,240.00, the

Appeals Unit's review of your appeal will utilize the estimate of \$49,000.00 you provided during your testimony.

During the hearing, you also asked that your expenses, which include your housing, car expenses, and utilities, be considered when calculating your annual household income. However, because Internal Revenue Service rules do not allow living expenses such as rent, utilities, cable, and phone to be deducted from the calculation of your adjusted gross income, they cannot be deducted when NYSOH computes your modified adjusted gross income for APTC purposes.

You are in a one-person household. You expect to file your 2018 income tax return as single and will claim no dependents on that tax return.

You reside in Westchester County, where the second lowest cost silver plan available for an individual through NYSOH costs \$515.72 per month.

An annual income of \$49,000.00 is 406.30% of the 2017 FPL for a one-person household. Because this is over the allowable limit to receive APTC, you would not be eligible to receive APTC.

Therefore, the October 28, 2017 eligibility determination notice is correct and is AFFIRMED.

Decision

The October 28, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You remain eligible to enroll in a full cost qualified health plan

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the

dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
