NOTICE OF DISMISSAL

On November 8, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you and your spouse were eligible for the Essential Plan, effective December 1, 2017. You appealed this determination.

On February 28, 2018, a Hearing Officer called you at the scheduled hearing time. You stated that you did not receive the evidence packet prepared by NYSOH for the hearing, and requested an adjournment. The Hearing Officer granted your request.

On March 9, 2018, a Hearing Officer called you at the re-scheduled hearing time. Your family member answered the phone and stated that you were unavailable to conduct the hearing, and requested an adjournment. The Hearing Officer granted that request.

On April 4, 2018, a Hearing Officer called you at the re-scheduled hearing time. You stated that you received the evidence packet prepared by NYSOH but that you did not review it, and requested an adjournment. The Hearing Officer denied your request. You stated that you wished to proceed with the hearing but before the Hearing Officer could swear you in, the call was terminated.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
