## **NOTICE OF DISMISSAL – FAILURE TO APPEAR**

On November 18, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your daughter was eligible to enroll in the Essential Plan for a cost of \$20.00 per month, effective January 1, 2018. You appealed this determination.

On December 21, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for January 11, 2018 at 9:00 a.m.

A Hearing Officer called you on January 11, 2018 at 9:00 a.m. An adjournment was granted as you requested your daughter be contacted directly.

A Hearing Officer contacted your daughter directly on the rescheduled hearing date of January 22, 2018. Your daughter answered and testified she could not proceed with the hearing as she was at a training that week and was not aware of the rescheduled hearing date. Your daughter requested a new date and time for the hearing.

On January 24, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for February 13, 2018 at 9:00 a.m.

On February 13, 2018, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH [REDACTED], at 9:00 a.m., 9:15 a.m., and 9:30 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

## **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NYSOH will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
