NOTICE OF DISMISSAL – FAILURE TO APPEAR

On October 12, 2017, NY State of Health (NYSOH) issued an enrollment confirmation notice, stating that your child was enrolled in a Medicaid Managed Care plan, effective October 1, 2017. You appealed this determination.

On December 20, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for January 9, 2018, at 10:00 a.m. On January 9, 2018, a Hearing Officer spoke with you. At that time, you requested an adjournment of the hearing so you could file Authorized Representative papers with NYSOH. The Hearing Office granted your request and your case was returned to NYSOH.

On January 10, 2018, NYSOH issued a new Notice of Hearing to advise you that the rescheduled hearing you requested was scheduled for February 1, 2018, at 10:00 a.m. On February 1, 2018, a Hearing Officer placed calls to the number you provided at 10:00 a.m. and 10:10 a.m. At the 10:10 a.m. call the person who answered stated you were not there and to contact you on your cell number which was the same number the Hearing Officer reached you on January 9, 2018. The Hearing Officer then placed calls at 10:10 a.m. and 10:25 a.m. to your cell number. The Hearing Officer was unable to reach you on any of these calls.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
