NOTICE OF DISMISSAL

[REDACTED] NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you remain conditionally eligible for Medicaid coverage for the treatment of emergency medical conditions only, effective November 1, 2017. You appealed this determination.

On December 21, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for January 11, 2018 at 11:00 a.m.

A Hearing Officer called you at 11:00 a.m. and at 11:15 a.m. you answered and began your hearing. Before the Hearing Officer could obtain the necessary testimony, the call was dropped. The Hearing Officer called you back at 11:33 a.m. and left a message that he would try and call you back at 11:45 a.m. At 11:45 a.m. the Hearing Officer tried calling you back again but was unable to reach you.

Since your hearing did not go forward and was not completed as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
