## NOTICE OF DISMISSAL – FAILURE TO APPEAR

On November 21, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating your children were eligible to purchase a full cost health plan, effective November 1, 2017. You appealed that determination.

On February 2, 2018, NYSOH issued a Notice of Hearing to advise you the hearing you requested was rescheduled for February 23, 2018, at 11:00 a.m.

On February 23, 2018, a Hearing Officer placed two calls to the telephone number that you provided to NYSOH, at 11:00 a.m. and 11:15 a.m., but was unable to reach you. At 11:16 a.m. the Hearing Officer attempted that number again wherein your spouse answered, indicated that you were not available at that number, and provided an office number and a cell phone number she identified as alternate contact numbers for you.

The Hearing Officer place two calls to the office number your spouse provided at 11:19 a.m. and 11:32 a.m., but was unable to reach you. Additionally, the Hearing Officer placed two calls to the cell phone number listed on your account at 11:19 a.m. and 11:35 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
