## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid for September and October 2017?

## Procedural History

On November 15, 2017, you submitted an application for financial assistance with health insurance and indicated that you were seeking help for paying for medical bills for the prior three months.

On November 16, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for the Essential Plan, effective December 1, 2017.

Also on November 16, 2017, NYSOH issued an eligibility determination notice stating that you were not eligible for Medicaid for September 1, 2017 through October 31, 2017 because the program you are eligible for cannot pay for any care you received in the past.

On November 20, 2017, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as it denied retroactive Medicaid for the months of September and October 2017.

On January 19, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing held open up to February 2, 2018, to allow you to submit supporting documents.

As of February 2, 2018, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid from September 1, 2017 through October 31, 2017.
- 2) You testified that you expect to file your 2017 federal income tax return as single, and claim no dependents.
- 3) You submitted an application for financial assistance on November 15, 2017.
- 4) Your application submitted on November 15, 2017, states that for the months of September and October 2017 your income was \$1,666.00. You testified that you were not sure what your income was for those months.
- 5) You testified that you are paid weekly with a personal check, and that those checks vary.
- 6) You did not submit any documentation to support your monthly income.
- 7) You testified that you do not plan on taking any deductions on your tax return

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State

plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

### Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that you were not eligible for Medicaid for September and October 2017.

You are in a one-person household; you file your taxes with a tax filing status of single and claim no dependents on your tax return.

You submitted an application for financial assistance on November 15, 2017 and requested help in paying for medical bills for the prior three months.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether or not that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

You testified that you are seeking Medicaid for September and October 2017.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. To be eligible for Medicaid in September and October 2017, you would have needed to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria during September and October 2017.

You testified that you are paid weekly. The application filed November 15, 2017 lists a monthly income of \$1,666.00 for September and October 2017. The record does not contain any information to contradict that amount. Therefore, the record supports that in the months of September and October 2017, you had a monthly household income of \$1,666.00. Since your income of \$1,666.00 was more than the \$1,387.00 monthly Medicaid limit for September and October 2017, NYSOH properly determined that you were not eligible for Medicaid coverage during those months.

Therefore, the November 16, 2017 notice of eligibility determination which stated that you were not eligible for Medicaid from September 1, 2017 through October 31, 2017 because the program you were eligible for cannot pay for any care you received in the past, is MODIFIED to state that you were not eligible for Medicaid for September and October 2017 because your income was over the allowable limit.

## **Decision**

The November 16, 2017 eligibility determination is MODIFIED to state that you were not eligible for Medicaid for September and October 2017 because your income was over the allowable limit.

## **How this Decision Affects Your Eligibility**

You are not eligible for Medicaid in the months of September and October 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
