Did NY State of Health properly determine that you were eligible for the Essential Plan with a \$20.00 per month premium payment?

Procedural History

On November 20, 2017, you applied for health insurance and financial assistance through NYSOH. That day, a preliminary eligibility determination was prepared stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective January 1, 2018.

Also, on November 20, 2017, you spoke to NYSOH's Account Review Unit and appealed that preliminary eligibility determination notice insofar as you were not eligible for the Essential Plan with a \$0.00 monthly premium.

On November 21, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective January 1, 2018.

On January 11, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed that same day and this decision is based on the record as developed at the time of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your tax return for 2018 with a tax filing status of single. You will not claim dependents on that tax return.
- 2) You are seeking insurance for yourself.
- 3) In the application that was submitted on November 20, 2017, you attested that your annual household income was \$20,020.00, consisting of income earned from your employment. During the hearing, you testified this amount was incorrect, and that your income was lower.
- 4) You testified that you could not provide your approximate annual income for either 2017 or 2018.
- 5) You testified that you could not provide your approximate monthly income.
- 6) The Hearing Officer offered to keep the hearing record open until January 26, 2018, in order for you to submit proof of your income, but you stated you did not wish to submit income documentation and requested the record close at the end of the hearing.
- 7) Your application states that you will not be taking any deductions on your 2018 tax return.
- 8) Your application states that you live in Kings County.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable FPL or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and

(6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage; therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan with a \$20.00 monthly premium payment.

You testified that you expect to file your tax return for 2018 with a tax filing status of single. Therefore, you are in a one-person household.

In the application that was submitted on November 20, 2017, you attested that your annual household income was \$20,020.00, consisting of income earned from your employment.

The Essential Plan is generally provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since an annual household income of \$20,020.00 is 166.00% of the 2017 FPL, NYSOH correctly found you to be eligible for the Essential Plan.

For household incomes greater than 150% of the FPL but below 200% of the FPL, there is a \$20.00 per month premium contribution. Since an annual household income of \$20,020.00 is 166.00% of the 2017 FPL, NYSOH correctly

found you to be eligible for the Essential Plan with a \$20.00 per month premium payment.

During the hearing, you testified that the income amount that was attested to in your November 20, 2017 application was incorrect. However, you could not provide any testimony regarding your approximate monthly or annual income. The Hearing Officer offered to keep the record open after the telephone portion of the hearing was complete, until January 26, 2018, for you to submit income documentation, but you did not wish to submit income documentation and requested the record close at the end of the hearing.

Since there is insufficient documentation of your income in the record, NYSOH Appeals Unit will not disturb the November 21, 2017 eligibility determination finding you eligible for the Essential Plan with a \$20.00 monthly premium.

Accordingly, the November 21, 2017 eligibility determination notice is AFFIRMED.

Decision

The November 21, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You are eligible for the Essential Plan with a \$20.00 monthly premium payment.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
