Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NYSOH properly determine that your oldest child was eligible to purchase a qualified health plan at full cost, effective January 1, 2018?

Procedural History

On November 20, 2017, NY State of Health (NYSOH) received your oldest child's application for health insurance.

On November 21, 2017, NYSOH issued an eligibility determination notice stating that your oldest child was eligible to purchase a qualified health plan at full cost, effective January 1, 2018. The notice stating that, based on information from federal and state data sources, it was determined your oldest child was already enrolled in or eligible for a public insurance program such as Tricare and was not eligible for Child Health Plus (CHP) or other insurance affordability programs.

On November 21, 2017 you spoke to NYSOH's Account Review Unit and appealed that determination insofar as your oldest child was not eligible for CHP.

On January 11, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- You testified that you expect to file your 2017 tax return with a tax filing status of married filing jointly. You will claim your three children as dependents on that tax return.
- 2) The application that was submitted on November 20, 2017, listed an annual household income of \$88,347.99. You testified that this amount was correct.
- 3) At the time of your November 20, 2017 application, your oldest child was
- 4) Your application states that you will not be taking any deductions on your 2017 tax return.
- 5) You testified that you are seeking your oldest child to be redetermined eligible for CHP.
- 6) You testified that your oldest child is currently enrolled in Tricare with his biological father's insurance through
- 7) You testified that it is a forty-five-minute to an hour drive to reach a provider near
- 8) NYSOH records show your child has active insurance through Tricare from November 1, 2017 through October 24, 2018.
- 9) Your application states that your child lives with you in

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

Child Health Plus (CHP) is a sliding-scale-premium program for children who are in a household that is over income for regular Medicaid (see New York Public Health Law (NY PHL) § 2510 et seq. and 42 USC § 1397aa). Eligibility rules are set out in NY PHL § 2511(2), as well as in the NYS Department of Health 2008-2012 Contract and Plan Manual.

A child who meets the eligibility requirements for CHP may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (NY PHL § 2511(2)(a)(iii)). To be eligible to enroll in CHP with subsidy payments, a child must not be "eligible for medical assistance"; that is, must not be eligible for Medicaid (NY PHL § 2511(2)(b)).

A child is not eligible for CHP subsidy payments if they have health care coverage under other health insurance (NY PHL § 2511(2)(c)).

The "period of eligibility" for CHP is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

Verification of Minimum Essential Coverage

NYSOH must verify whether an applicant is eligible for minimum essential coverage other than through an eligible employer-sponsored plan, Medicaid, CHP, or the BHP, using information obtained by transmitting identifying information specified by HHS to HHS for verification purposes (45 CFR § 155.330(b)).

Minimum essential coverage includes most government-sponsored insurance plans such as Medicaid, Medicare, CHP, Tricare, Veterans' Health Coverage, and eligible employer-sponsored insurance (26 USC § 5000A(f)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your oldest child was eligible to purchase a qualified health plan at full cost and not eligible for CHP, effective January 1, 2018.

A child is eligible to enroll in CHP if they meet the non-financial requirements, are not eligible for Medicaid, and have a household income below 400% of the FPL. One of the additional non-financial requirements for receipt of subsidy payments for CHP is that the child not have health care coverage under other health insurance.

NYSOH is required to verify whether any applicant is eligible for minimum essential coverage other than through eligible employer-sponsored plans, Medicaid, CHP, or the BHP.

NYSOH reviewed your child's application for financial assistance on November 20, 2017. The result of that application was that state and federal data sources showed your oldest child is eligible for and actively enrolled in health insurance through Tricare. You testified this was true as your oldest child is enrolled in Tricare with his biological father's health insurance through

Tricare is considered minimum essential coverage as defined by applicable regulations and would therefore be considered other insurance for which CHP subsidy payments and enrollment would not be allowed so long as the child remains in that insurance coverage. Your NYSOH application shows your oldest child's coverage through Tricare is active from November 1, 2017 through October 24, 2018.

Therefore, NYSOH's November 21, 2017 eligibility determination notice stating your oldest child was eligible to purchase a qualified health plan at full cost and not eligible for CHP or other insurance affordability programs through NYSOH, effective January 1, 2018, is correct and is AFFIRMED.

Decision

The November 21, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your child remains eligible to purchase a qualified health plan at full cost, effective January 1, 2018.

Your child is not eligible for Child Health Plus, effective January 1, 2018, because he has active health insurance coverage with Tricare.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
