Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a qualified health plan and the application of advance payments of the premium tax credit (APTC) were effective October 1, 2017?

Procedural History

On October 16, 2017, you updated your NYSOH application attesting to an annual household income of \$24,210.16.

On October 17, 2017, NYSOH issued a notice of eligibility redetermination stating that you were eligible to receive up to \$324.00 per month in APTC and, if you selected a silver-level qualified health plan, for cost-sharing reductions (CSR). This eligibility was effective December 1, 2017.

Also on October 17, 2017, NYSOH issued a letter confirming your enrollment in a qualified health plan with a monthly premium responsibility of \$390.09, after your APTC of \$324.00 was applied, both effective October 1, 2017.

On November 22, 2017, you spoke to NYSOH's Account Review Unit and appealed the enrollment confirmation notice insofar as it began your financial assistance eligibility and enrollment in a qualified health plan on October 1, 2017 and not December 1, 2017.

On January 10, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on October 16, 2017.
- 2) On October 17, 2017, NYSOH issued a notice of eligibility redetermination stating that you were eligible to receive up to \$324.00 per month in APTC and CSR, effective December 1, 2017.
- 3) You testified, and the record reflects, that you selected a qualified health plan on October 16, 2017.
- 4) You testified that when you called NYSOH on October 16, 2017 that a NYSOH representative told you that your coverage was going to begin on December 1, 2017.
- 5) Your enrollment in the plan became effective October 1, 2017.
- 6) You testified that you did not want your health insurance coverage to begin on October 1, 2017.
- 7) You testified that you did not use your health insurance coverage during October 2017.
- 8) You testified that you saw a doctor in October 2017 and paid out of pocket for [REDACTED] and for [REDACTED]
- 9) You testified that you need your qualified health plan and eligibility for financial assistance to begin on December 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Redetermination During a Benefit Year

When a redetermination is issued as a result of a change in an applicant's information, NYSOH must generally make that redetermination effective on the first day of the month following the date NYSOH is notified of the change (45 CFR § 155.330 (f)(1)(ii)). However, NYSOH may determine that its policy will be that any change made after the 15th of any month will not be effective until the first of the second following month (45 CFR § 155.330(f)(2)).

When an eligibility redetermination results in a change in the amount of advance payments of the premium tax credit (APTC) for the benefit year, NYSOH must recalculate the amount of APTC in such a manner as to account for any advance payments already made on behalf of the tax filer, such that the recalculated advance payment amount is projected to result in total advance payments for the benefit year that correspond to the tax filer's total projected premium tax credit for that benefit year (45 CFR § 155.330(g)).

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in a qualified health plan, as well as the application of APTC, was effective October 1, 2017.

The record shows that October 16, 2017 you updated the information in your NYSOH account and submitted a request to enroll in a qualified health plan. On October 17, 2017, NYSOH issued an enrollment confirmation notice stating that your enrollment in your qualified health plan was effective October 1, 2017 and that APTC would be applied to your monthly premium effective October 1, 2017.

You testified that you did not want your health insurance coverage to begin on October 1, 2017.

You testified that you saw a doctor in October 2017 and paid out of pocket for [REDACTED] and [REDACTED].

You testified that you did not use your health insurance coverage during October 2017.

You testified that when you called NYSOH on October 16, 2017 that a NYSOH representative told you that your coverage was going to begin on December 1, 2017.

When an individual changes information in their application on or before the 15th of any month, NYSOH must make the redetermination that results from the change effective the first day of the following month. Additionally, the date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including fifteenth day of a month goes into effect on the first day of the following month. A plan selected after the 15th day of the month goes into effect the first day of the second following month.

Since you selected a qualified health plan on October 16, 2017, your enrollment should have been effective on the first day of the second following month; that is on December 1, 2017.

Therefore, NYSOH's October 17, 2017 enrollment confirmation notice is MODIFIED insofar as your enrollment in your qualified health plan as well as your APTC should be made effective December 1, 2017.

Your case is being RETURNED to NYSOH to enroll you in your qualified health plan with APTC, effective December 1, 2017.

Your case is being RETURNED to NYSOH to enroll you in your qualified health plan with APTC, effective December 1, 2017.

How this Decision Affects Your Eligibility

NYSOH incorrectly enrolled you into a qualified health plan with APTC, effective October 1, 2017.

Your case is being RETURNED to NYSOH to enroll you in your qualified health plan with APTC, effective December 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
