NOTICE OF DISMISSAL

On November 8, 2017, NY State of Health (NYSOH) issued a notice of enrollment confirmation, stating that you were enrolled in the Essential Plan, effective November 1, 2017. You appealed this determination.

On January 24, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for February 13, 2018, at 3:00 p.m.

A Hearing Officer called you at 3:10 p.m. on February 13, 2018, with the assistance of [REDACTED]. Although you answered the call, you stated that you were [REDACTED] and requested a call back in a half hour. The Hearing Officer declined to adjourn your hearing to 3:40 p.m. The call was then disconnected on your end, with the Hearing Officer and interpreter remaining on the line.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
