NOTICE OF DISMISSAL – INVALID APPEAL REQUEST

On January 4, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan, effective February 1, 2017.

On January 30, 2017, NYSOH issued a plan enrollment notice confirming your enrollment in an Essential Plan, effective February 1, 2017.

On September 2, 2017, NYSOH issued a disenrollment notice stating that your enrollment in your Essential Plan was terminated, effective August 31, 2017, because a premium payment had not been received by the health plan.

You testified at the hearing on March 14, 2018, which was based on your November 22, 2017 appeal request, that you are seeking health insurance coverage for the month of August 2017.

You further testified that you paid your premiums to your Essential Plan on time, but missed a payment in August 2017 because you [REDACTED]

According to your NYSOH account, you were disenrolled from your Essential Plan, effective August 31, 2017.

You testified that you filed an appeal because your health plan advised you that you did not have coverage and you have received bills for [REDACTED] rendered in August 2017.

Why Your Appeal Request Is Not Valid

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (4) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Your appeal was requested to dispute termination of coverage by your Essential Plan for the month of August 2017 because you failed to pay monthly premium on time. This issue relates to coverage and payment of premiums, which is not an issue that the Appeals Unit of NYSOH is authorized to address. Therefore, we must dismiss your appeal.

However, it is clear from the record that you were enrolled in the Essential Plan until August 31, 2017, in that the September 2, 2017 disenrollment notice indicates that your coverage ended on August 31, 2017. Therefore, your case is RETURNED to Plan Management to investigate whether or not you were enrolled in the Essential Plan for August 2017 and, if so, to confirm your coverage with your health plan.

How does this Dismissal Affect Your Eligibility?

This decision does not change your current eligibility for or enrollment in a qualified health plan, or the monthly premium amount that you pay for your health plan.

It does return your case to Plan Management Unit to further investigate the issue of the termination date of coverage in your Essential Plan.

You may have additional options outside of the Appeals Unit of New York State of Health, such as through your plan or through the Department of Financial Services.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. In that writing, you must explain why you think this dismissal should be vacated and if your issue differs from the one discussed above.

If you ask us in writing to vacate this dismissal, NYSOH's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by NYSOH.
