## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On November 23, 2017, NY State of Health (NYSOH) issued an enrollment notice confirming your enrollment in the Essential Plan 1 Plus Dental and Vision for a cost of \$47.93 per month, effective January 1, 2018. You appealed that determination.

On January 30, 2018, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you had some expenses with medications not covered during the months of November and December 2017 which you were no longer concerned about. You testified you no longer wanted to appeal the start date of your Essential Plan 1 coverage.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

## **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
