## Decision

Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your qualified health plan ended effective January 1, 2018?

# **Procedural History**

On January 5, 2017, NYSOH issued a renewal notice stating that you were eligible to purchase a qualified health plan at full cost, effective March 1, 2017.

On February 1, 2017, NYSOH issued an enrollment notice confirming your enrollment in a qualified health plan, effective March 1, 2017.

On October 28, 2017, NYSOH issued a renewal notice stating that you were eligible to purchase a qualified health plan at full cost, effective January 1, 2018.

On November 18, 2017, NYSOH issued an enrollment notice confirming your enrollment in a qualified health plan, effective January 1, 2018.

On November 22, 2017, you updated your application for health insurance. Specifically, you indicated that you no longer wanted to receive coverage through NYSOH. That day, a preliminary eligibility determination was issued, stating that you were no longer eligible to enroll in coverage through NYSOH, effective January 1, 2018. Also on November 22, 2017, you contacted the NYSOH Account Review Unit and appealed the date you were disenrolled from your qualified health plan, requesting the disenrollment be made effective November 30, 2017.

On November 23, 2017, NYSOH issued a notice of eligibility determination stating that you were no longer eligible for health insurance through NYSOH, effective January 1, 2018.

Also on November 23, 2017, NYSOH issued a disenrollment notice indicating that coverage in your qualified health plan would end effective January 1, 2018.

On January 25, 2018, you had a telephone hearing with a Hearing Officer from the NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the proceeding.

# **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you personally selected the qualified health plan which began on March 1, 2017, as it was the least expensive plan of the plans available to you.
- 2) You testified that you became eligible for insurance through your employer as of January 1, 2018.
- 3) You testified that towards the end of November 2017, you learned that you would be eligible for health insurance through your employer.
- You testified that towards the end of November 2017, you contacted NYSOH to disenroll yourself from your qualified health plan through NYSOH. Your NYSOH account reflects that this request took place on November 22, 2017.
- 5) You testified that you paid a premium to your qualified health plan for the month of December 2017.
- 6) You testified that you did not use your qualified health plan in the month of December 2017.
- 7) You testified that you are seeking disenrollment from your qualified health plan effective November 30, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

# **Applicable Law and Regulations**

#### Termination of a Qualified Health Plan

NYSOH must permit an enrollee to terminate his or her coverage with a qualified health plan coverage, with appropriate notice to the NYSOH or qualified health plan (45 CFR § 155.430(b)(1)(i)).

For enrollee-initiated terminations, the last day of coverage is either:

- The termination date specified by the enrollee, if the enrollee provides reasonable notice (at least 14 days before the requested termination date);
- 2) Fourteen days after the enrollee requests the termination, if they do not provide reasonable notice; or
- On a date on or after the date the enrollee requests the termination, if the enrollee's qualified health plan issuer and the enrollee agree to such a date

(45 CFR § 155.430(d)(2)(i)-(iii)).

NYSOH must permit an enrollee to retroactively terminate or cancel their enrollment in a qualified health plan if:

- 1) The enrollee demonstrates that they attempted to terminate their coverage and experienced a technical error that did not allow the coverage to be terminated, and requests retroactive termination within 60 days after they discovered the technical error.
- 2) The enrollment in the qualified health plan was unintentional, inadvertent, or erroneous and was the result of the error or misconduct of an officer, employee, or agent of NYSOH or HHS, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities. Such enrollee must request cancellation within 60 days of discovering the unintentional, inadvertent, or erroneous enrollment.
- 3) The enrollee was enrolled in a qualified health plan without their knowledge or consent by any third party, including third parties who have no connection with the Exchange, and requests cancellation within 60 days of discovering of the enrollment.

(45 CFR § 155.430(b)(2)(iv)(A-C)).

NYSOH permits a qualified health plan to terminate an individual's coverage if (1) the enrollee is no longer eligible for coverage or (2) non-payment of the premiums by the enrollee (45 CFR § 155.430(b)(2)(i)-(ii)).

## Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in your qualified health plan ended effective January 1, 2018.

On January 5, 2017, NYSOH issued a renewal notice stating that you were eligible to purchase a qualified health plan at full cost, effective March 1, 2017. You subsequently enrolled into a qualified health plan.

On November 23, 2017, NYSOH issue a disenrollment notice indicating you would be disenrolled from your qualified health plan effective January 1, 2018.

You testified that you are seeking disenrollment from your qualified health plan effective November 30, 2017.

NYSOH must permit an enrollee to be retroactively disenrolled from their qualified health plan if the enrollee demonstrates that there was a technical error that should have allowed them to terminate coverage earlier, or if their enrollment in the plan was unintentional, inadvertent, or erroneous and was the result of the error or misconduct of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities, or the enrollee was enrolled into a qualified health plan without their knowledge or consent by a third party.

There is no indication in the record that your enrollment in a qualified health plan as confirmed in the February 1, 2017 enrollment notice was unintentional, inadvertent, or erroneous, nor was your enrollment in a qualified health plan the result of the error or misconduct of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities. Furthermore, there is no indication that your enrollment in a qualified health plan as confirmed in the February 1, 2017 enrollment notice was without your knowledge or consent.

Therefore, there is no basis to find that NYSOH must permit you to retroactively terminate or cancel your enrollment in a qualified health plan.

On October 28, 2017, NYSOH issued a renewal notice stating that you were eligible to purchase a qualified health plan at full cost, effective January 1, 2018.

On November 18, 2017, NYSOH issued an enrollment notice stating that you had been reenrolled into the same qualified health plan for 2018 that you had been enrolled in for 2017, which enrollment was to begin on January 1, 2018.

The record reflects that on November 22, 2017 you contacted NYSOH and requested that you be disenrolled from your qualified health plan as you no longer wanted to remain enrolled.

Enrollees must be allowed to terminate their coverage with a qualified health plan at the date they specify if they provide reasonable notice to NYSOH or to their health plan. Reasonable notice is defined as at least 14 days prior to the requested termination date.

As you requested to terminate your coverage on November 22, 2017, which is eight days prior to November 30, 2017, you did not provide reasonable notice that you wanted to terminate your enrollment in your qualified health plan as of November 30, 2017.

NYSOH terminated your insurance coverage with your qualified health plan effective January 1, 2018, which is the first day your reenrollment into your qualified health plan for 2018 was to begin.

Since you do not qualify to be retroactively disenrolled from your coverage and you did not provide reasonable notice to NYSOH, NYSOH properly determined that your disenrollment in your qualified health plan was effective January 1, 2018.

Therefore, the November 23, 2017, disenrollment notice is AFFIRMED.

## Decision

The November 23, 2017 disenrollment notice is AFFIRMED.

## Effective Date of this Decision: January 30, 2018

## How this Decision Affects Your Eligibility

This decision does not change your disenrollment date. Your enrollment in your qualified health plan ended as of January 1, 2018.

# If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
