Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NYSOH properly determine that your oldest child's enrollment in his Child Health Plus plan was effective November 1, 2017?

Procedural History

According to your NY State of Health (NYSOH) account, you updated your application for health insurance on August 23, 2017. That day, your oldest child (child) was put in pending Medicaid status, with proof of income required to confirm his eligibility.

Also on August 23, 2017, you submitted proof of household income documentation ([REDACTED]). Your proof of income was validated by NYSOH on August 28, 2017.

On August 29, 2017, NYSOH issued an eligibility determination notice stating that your child was eligible for Child Health Plus (CHP), effective October 1, 2017. The notice stated that you needed to pick a health plan for your child.

On October 12, 2017, NYSOH issued a plan enrollment notice, based on your plan selection on October 11, 2017, confirming your child's enrollment in a CHP plan as of November 1, 2017.

On November 27, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's CHP plan insofar as it did not begin October 1, 2017.

On January 18, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account, you updated your child's application for financial assistance on August 23, 2017. That day, your child was placed in pending Medicaid status because NYSOH could not verify the income you attested to in that application.
- 2) Pursuant to NYSOH's request, you submitted proof of household income documentation (see Documents [REDACTED]). These documents were validated by NYSOH on August 28, 2017.
- 3) On August 28, 2017, your child was found eligible for CHP and you were able to select a health plan on his behalf, as confirmed by the August 29, 2017 plan enrollment notice.
- 4) You testified that you did receive the August 29, 2017 eligibility determination notice stating that you needed to pick a health plan for your child. However, you believed the notice was in error because you had requested that your child be enrolled in a health plan when you applied for health insurance for your child on August 23, 2017.
- 5) You testified that you did not know that you needed to pick a health plan for your child until you went to [REDACTED] to pick up your child's prescriptions and were told your child had no health insurance.
- 6) According to your NYSOH account, on October 11, 2017, NYSOH received your child's updated application for health insurance. You enrolled your child in a CHP plan that day with an effective start date of November 1, 2017.
- 7) You testified that you are seeking that your child be enrolled in his CHP plan as of October 1, 2017, because you have medical bills for that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid, or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your child’s enrollment in his CHP plan was effective November 1, 2017.

On August 28, 2017, your child was originally found eligible for CHP and you were able to select a health plan on his behalf, as was reflected in the August 29, 2017 notice.

You testified that you did receive the August 29, 2017 eligibility determination notice stating that you needed to pick a health plan for your child. Although you believed that the notice was in error because you had requested that your child be enrolled in a health plan when you applied for health insurance on August 23, 2017, your failure to heed the August 29, 2017 notice and contact NYSOH to

update your child's enrollment is not an error or mistake of NYSOH, its agents, or instrumentalities.

Therefore, the record reflects that NYSOH properly notified you that your child's plan selection needed to be made to ensure your child's enrollment in his CHP plan.

You first enrolled your child into a CHP plan through NYSOH on October 11, 2017.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected between the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you first selected your child's CHP plan on October 11, 2017, NYSOH properly began your child's CHP plan on the first day of the month following October 2017; that is, on November 1, 2017.

Therefore, NYSOH's October 12, 2017 plan enrollment notice is correct and must be AFFIRMED.

Decision

The October 12, 2017 plan enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility.

The effective date of your child's CHP plan is November 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

The October 12, 2017 plan enrollment notice is AFFIRMED.

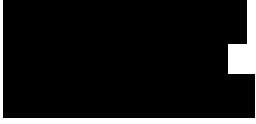
This decision does not change your child's eligibility.
