NOTICE OF DISMISSAL

On November 21, 2017, NY State of Health (NYSOH) issued an enrollment notice confirming, in relevant part, that as of November 20, 2017, you and your spouse were enrolled in an Essential Plan with an enrollment start date of January 1, 2018. You requested an appeal insofar as the enrollment start date of your and your spouse's health plan.

On December 28, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for January 22, 2018, at 11:00 am.

On January 22, 2018, a Hearing Officer from the NYSOH Appeals Unit contacted you using the telephone number that you provided to NYSOH at the scheduled hearing time. You answered and stated that you did not want to proceed with the appeals process.

Based on the foregoing, we find that you were given notice of the formal hearing in writing and were unwilling to go forward with the appeal at the scheduled time.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NY State of Health will not review your appeal.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
