Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your children's enrollment in their Child Health Plus plan was effective December 1, 2017?

Procedural History

On November 4, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, based on your November 3, 2017 application, stating that your children were eligible to enroll in Child Health Plus with a \$30.00 monthly premium, effective December 1, 2017.

Also on November 4, 2017, NYSOH issued a notice of enrollment, based on your plan selection on November 3, 2017, stating that your children were enrolled in a Child Health Plus plan, and that this enrollment in the plan would start December 1, 2017.

On November 29, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's Child Health Plus plan insofar as it did not begin November 1, 2017.

On January 29, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing your children's eligibility and are seeking for your children's enrollment in their Child Health Plus plan to begin on November 1, 2017.
- 2) You testified that your children previously had coverage through your employer, which coverage ended on October 31, 2017.
- 3) You submitted an application on-line to NYSOH for financial assistance on November 3, 2017.
- 4) You testified, and the record reflects, that you enrolled your children into a Child Health Plus plan on November 3, 2017.
- 5) You testified that you placed a call to NYSOH on October 30, 2017 regarding obtaining coverage through NYSOH for your children, however, you were told that you could not submit an application for your children at that time, as your children were still enrolled in coverage through your employer.
- 6) You testified that your children have medical bills from November 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs

as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue is whether NYSOH properly determined that your children’s enrollment in their Child Health Plus plan was effective December 1, 2017.

You testified that you submitted an application on-line for coverage for your children on November 3, 2017 and selected a Child Health Plus plan for enrollment that day.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

However, you testified that on October 30, 2017, you contacted NYSOH in order to obtain coverage for your children through NYSOH, but were told that you could not submit an application at that time because your children still had coverage through your employer.

Had you been permitted to submit an application on October 30, 2017, your children could have been found eligible for Child Health Plus as soon as October 30, 2017, and you could have selected a Child Health Plus plan for enrollment for your children that day.

Had you selected a Child Health Plus plan for enrollment on October 30, 2017, your children’s enrollment in their Child Health Plus plan would have been effective the first day of the second month following after October 30, 2017; that is on December 1, 2017.

Therefore, the November 4, 2017 eligibility determination notice and the November 4, 2017 enrollment confirmation notice stating that your children’s eligibility for and enrollment in their Child Health Plus plan was effective December 1, 2017, are correct and must be AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your children's eligibility.

The effective date of your children's Child Health Plus plan is December 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
