Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that your eligibility for the Essential Plan ended effective November 30, 2017?

Did NYSOH properly determine that your eligibility for and enrollment in the Essential Plan was effective January 1, 2018?

Procedural History

On July 14, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan for a limited time, effective August 1, 2017. The notice further directed you to provide documentation confirming your income before October 11, 2017.

Also on July 14, 2017, NYSOH issued a notice confirming your enrollment in an Essential Plan, effective August 1, 2017.

On October 17, 2017, NYSOH issued an eligibility determination notice stating that you were newly eligible to purchase a qualified health plan at full cost. The notice stated that you were not eligible to enroll in the Essential Plan because NYSOH did not receive the income documentation needed to verify the income listed in your application. This eligibility was effective December 1, 2017.

On October 18, 2017, NYSOH issued a disenrollment notice stating that your enrollment in the Essential Plan would end as of November 30, 2017, because you were no longer eligible to remain in your plan.

On November 30, 2017, you updated your application for financial assistance. That day, a preliminary eligibility determination was prepared stating that you were eligible to enroll in the Essential Plan, effective January 1, 2018, and you selected a plan for enrollment.

Also on November 30, 2017 you spoke to NYSOH's Account Review Unit and appealed the termination of your Essential Plan for the month of December 2017.

On December 1, 2017, NYSOH issued a notice of eligibility determination, based on your November 30, 2017 application, stating that you were eligible to enroll in the Essential Plan for a limited time, effective January 1, 2018.

Also on December 1, 2017, NYSOH issue a notice of enrollment confirmation, based on your plan selection on November 30, 2017, stating that you were enrolled in an Essential Plan effective January 1, 2018.

On February 2, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record support the following findings of fact:

- 1) You testified, and your NYSOH account confirms, that you receive alerts regarding notices from NYSOH by electronic mail.
- 2) You testified that you received two electronic alerts to your e-mail address on file during July 2017, but failed to open them. These electronic alerts were sent by NYSOH account regarding notice stating that your eligibility was only conditional and that you needed to provide documentation of your income.
- 3) You testified that you did not know that you needed to submit documentation of your income until you received a subsequent email regarding a notice that indicated that your Essential Plan coverage would end effective November 30, 2017.
- 4) Your NYSOH account indicates that on October 16, 2017 your application was re-processed and you were found no longer eligible for the Essential Plan as of November 30, 2017.

- 5) You updated the income information in your NYSOH account on November 30, 2017.
- 6) You testified that you are seeking reinstatement of your Essential Plan for the month of December 2017 since you incurred medical expenses during that month, which were not covered.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Verification of Eligibility for the Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

NYSOH must verify the eligibility of an applicant for the Essential Plan consistent with the standards set in 45 CFR § 155.315 and § 155.320 (New York's Basic Health Plan Blueprint, pgs. 16-17, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>; 42 CFR § 600.345(a)(2)).

An applicant is required to attest to their household's projected annual income. (45 CFR § 155.320(c)(3)(ii)(B)). For all individuals whose household income is needed, NYSOH must request tax return data from the Secretary of the Treasury and data regarding Social Security benefits from the Commissioner of Social Security to confirm that the information the applicant is attesting to is accurate (45 CFR § 155.320(c)(1)(i); 45 CFR § 155.320(c)(3)(ii)(A)).

If income data is unavailable, or if an applicant's attestation is not reasonably compatible with the income data NYSOH obtains, NYSOH must request additional information from the applicant to resolve the inconsistency (45 CFR §155.320 (c)(3)(iii), (iv)).

NYSOH must provide the applicant with notice of the inconsistency in their account and 90 days to provide satisfactory documentary evidence to resolve the

inconsistency (45 CFR § 155.315 (f)(2)). If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine the applicant's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation (45 CFR § 155.315(f)(2), (g)).

Upon making an eligibility redetermination, NYSOH must notify the applicant and implement any updates in eligibility to the Essential Plan effective the first day of the following month for changes received by NYSOH from the first to the fifteenth of any month (45 CFR § 155.420(b)(1)(i); *see also* 42 CFR § 600.320(c)). For updates received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR § 155.420(b)(1)(ii); *see also* 42 CFR § 600.320(c)).

Electronic Notices

Applicants may choose to receive notices and information from NYSOH either by electronic alerts or by regular mail. If the applicant elects to receive electronic notices, NYSOH must send an email or other electronic communication alerting the individual that a notice has been posted to the applicant's account (42 CFR § 600.330(e); 42 CFR § 435.918(b)(4)).

Additionally, if an electronic alert regarding a notice in an individual's NYSOH account fails, NYSOH must send out the notice by regular mail within three days of the failed alert (42 CFR § 435.918(b)(5)).

Legal Analysis

The first issue under review is whether NYSOH properly determined that your eligibility for the Essential Plan ended effective November 30, 2017.

An individual requesting financial assistance to help pay for the cost of coverage provided through NYSOH is required to attest to his or her household's projected annual income. For individuals seeking enrollment in the Essential Plan, NYSOH must request income data from federal data sources to verify an individual's income attestation.

If NYSOH cannot verify an individual's attestation, it must provide the individual with notice of the inconsistency and provide a period of 90 days from the date notice is received to resolve the inconsistency.

In the eligibility determination issued on July 14, 2017, you were advised that you were eligible for the Essential Plan for a limited time, and that you needed to confirm your household's income before October 11, 2017.

You testified that you did not receive any notice from NYSOH telling you that you needed to provide income documentation to confirm your eligibility. However, you testified that you received two electronic alerts to your e-mail address on file during July 2017, but failed to open them. These electronic alerts were sent by NYSOH, advising you to log into your NYSOH account to check for new notifications that were issued to you. The July 14, 2017 eligibility determination notice posted to your account advised you that your Essential Plan eligibility was only conditional and that you needed to provide documentation of your income.

Therefore, NYSOH properly notified you of an inconsistency in your account and that documentation was needed to confirm the income you listed in the account.

If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine an individual's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation.

Accordingly, your eligibility for the Essential Plan terminated as of November 30, 2017 because you did not submit documentation and did not adequately demonstrate that you could not provide documentation to confirm your income.

Therefore, the October 17, 2017 eligibility determination notice and October 18, 2017 disenrollment notice are AFFIRMED.

The second issue is whether NYSOH properly determined that your eligibility for and enrollment in the Essential Plan was effective January 1, 2018

You testified, and your account confirms, that you updated your NYSOH application on November 30, 2017. That day you selected an Essential Plan for enrollment.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

Since on November 30, 2017, you selected an Essential Plan, your enrollment would properly take effect on the first day of the second month following November 2017; that is, on January 1, 2018.

Therefore, the December 1, 2017 eligibility determination notice, and the December 1, 2017 enrollment confirmation notice stating that your enrollment in the Essential Plan was effective January 1, 2018, are correct and must be AFFIRMED.

Decision

The October 17, 2017 eligibility determination notice and October 18, 2017 disenrollment notice are AFFIRMED.

The December 1, 2017 eligibility determination and enrollment notices are AFFIRMED.

How this Decision Affects Your Eligibility

Your Essential Plan coverage ended effective November 30, 2017, and resumed effective January 1, 2018.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
