## NOTICE OF DISMISSAL

On November 29, 2017, NY State of Health (NYSOH) issued an enrollment notice confirming, in relevant part, that as of November 28, 2017, you were enrolled in a Medicaid Managed Care (MMC) plan with an enrollment start date of January 1, 2018. You requested an appeal insofar as the enrollment start date of your health plan.

On January 4, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for January 25, 2018, at 10:00 am.

On January 25, 2018, a Hearing Officer from the NYSOH Appeals Unit contacted you using the telephone number that you provided to NYSOH at the scheduled hearing time. An individual answered, and the telephone call was terminated. Subsequently, the Hearing Officer attempted to contact you; however, the call went straight to your voicemail.

Based on the foregoing, we find that you were given notice of the formal hearing in writing and were unwilling to go forward with the appeal at the scheduled time.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

### **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NY State of Health will not review your appeal.

The NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
