NOTICE OF DISMISSAL – FAILURE TO APPEAR

On November 30, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination and a corresponding enrollment confirmation notice, stating that you were eligible for and enrolled in an Essential Plan, effective January 1, 2018. You appealed this determination and enrollment notice.

On January 16, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for February 7, 2018, at 10:00 a.m. On February 7, 2018, a Hearing Officer called and you requested your case to be rescheduled to a later date. The Hearing Officer granted your request. On February 14, 2018, NYSOH issued a Notice of Hearing to advise you that your hearing had been rescheduled to February 28, 2018 at 10:00 a.m.

On February 28, 2018, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 10:00 a.m., 10:10 a.m., and 10:26 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
