Dear [REDACTED],

On October 22, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for an advance premium tax credit (APTC) of up to \$283.00 per month and, if you selected a silver-level plan, eligible for cost-sharing reductions (CSR), effective November 1, 2017. You appealed that determination.

On February 15, 2018, a Hearing Officer from the Appeals Unit of NYSOH called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you testified that you were not appealing your APTC or CSR, but rather the way you are billed by your provider and/or reimbursed by your insurance carrier, Healthfirst, due to your 50% co-insurance responsibility under your bronze-level plan. You further testified that you may seek to address this issue by contacting NYS Department of Financial Services, at (800) 342-3736 or <https://myportal.dfs.ny.gov/web/guest-applications/consumer-complaint?hn=1&forward=new>, to file a complaint against Healthfirst.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

The Appeals Unit of NYSOH will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
