Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Essential Plan through MVP was effective January 1, 2018?

Procedural History

On October 31, 2017, NYSOH issued an eligibility determination notice stating that you were eligible for the Essential Plan, on a limited basis, with a \$20.00 monthly premium, effective December 1, 2017.

Also on October 31, 2017, NYSOH issued a notice of enrollment confirmation stating that you were enrolled in an Essential Plan through Fidelis, with a start date of December 1, 2017.

On December 4, 2017, you terminated your enrollment in your Fidelis Essential Plan, and selected a new Essential Plan through MVP.

Also on December 4, 2017, NYSOH prepared a preliminary eligibility determination stating that the enrollment start date of your Essential Plan, MVP, was January 1, 2018.

Also on December 4, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Essential Plan, MVP insofar as it did not begin December 1, 2017.

On December 5, 2017, NYSOH issued a notice of enrollment confirmation stating that you were enrolled in an Essential Plan, MVP and that your enrollment start date was January 1, 2018.

On February 6, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing the start date of your Essential Plan, MVP.
- 2) NYSOH records reflect that you were enrolled in a Fidelis Essential Plan since December 1, 2017.
- 3) You testified that you called NYSOH on December 4, 2017 and cancelled your Fidelis Essential Plan.
- 4) You testified that your coverage with your Essential Plan, Fidelis ended December 31, 2017.
- 5) You testified that also on December 4, 2017 you selected your MVP Essential Plan and that your enrollment was effective on January 1, 2018.
- 6) You testified that you want your MVP Essential Plan to begin on December 1, 2017 because you incurred a medical bill in December 2017 and your medical provider did not accept your coverage through Fidelis.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in an Essential Plan, MVP, was effective January 1, 2018.

NYSOH records reflect that you were enrolled in an Essential Plan, Fidelis since December 1, 2017. You testified that you called NYSOH on December 4, 2017, cancelled your Essential Plan, Fidelis and that the coverage end date was December 31, 2017. You testified that also on December 4, 2017 that you enrolled into an Essential Plan, MVP.

The date on which an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On December 4, 2017, you selected an Essential Plan, MVP so it properly took effect on the first day of the following month; that is, on January 1, 2018.

Therefore, the December 5, 2017 enrollment confirmation notice stating that your enrollment in your Essential Plan, MVP would be effective January 1, 2018, was correct and must be AFFIRMED.

Decision

The December 5, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Essential Plan, MVP is January 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
