Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were eligible for the Essential Plan?

Did NY State of Health properly determine that you were ineligible for Medicaid?

Procedural History

On November 28, 2017, NY State of Health (NYSOH) received your updated application for financial application with health insurance.

On November 29, 2017, NYSOH issued an eligibility determination notice stating, in part, that you were eligible to enroll in an Essential Plan with a \$20.00 monthly premium for a limited time, effective January 1, 2018. That notice also stated that you were not eligible for Medicaid because your annual household income was over the allowable income limits for that programs. This notice further directed you to submit income documentation by February 26, 2018 in order to confirm your eligibility.

Also on November 29, 2017, NYSOH issued a plan enrollment notice confirming, in part, your enrollment in an Essential Plan with a \$20.00 monthly premium, effective January 1, 2018.

On December 4, 2017, you uploaded one document to your NYSOH account. This document was validated that day, and an application for financial assistance was submitted on your behalf. This application contained no change in expected income. That day, a preliminary eligibility determination was prepared stating, in part, that you were eligible to enroll in an Essential Plan with a \$20.00 monthly premium, effective January 1, 2018.

Also on December 4, 2017, you spoke to NYSOH's Account Review Unit and appealed the eligibility determination insofar as you were not eligible for Medicaid.

On December 5, 2017, NYSOH issued an eligibility determination, based on the December 4, 2017 eligibility determination notice, stating, in part, that you were fully eligible to enroll in an Essential Plan with a \$20.00 monthly premium, effective January 1, 2018.

On February 7, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and the Hearing Officer held the record open until February 22, 2018, to allow you time to submit supporting income documentation.

On February 7, 2018, NYSOH received your supporting documents by fax. That day, these documents were made part of the record as Appellant's Exhibit #1 and the record was closed.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH application, you are seeking health insurance for yourself and your child.
- 2) You testified that you are only appealing your eligibility determination.
- 3) You testified that you expect to file your tax return for 2018 with a tax filing status of single. You will claim no dependents on that tax return.
- 4) You testified that your parents claim your child on their tax return and that they have custody of your child.
- 5) The application that was submitted on November 28, 2017, listed annual household income of \$20,868.00, consisting of income you receive from your Social Security Disability benefits. You testified that this amount was correct.

- 6) You testified, and provided documentation to show, that you receive \$1,739.00 per month in Social Security Disability benefits.
- 7) You testified, and provided documentation, that December 2017 was the first month in which you received a payment from your Social Security Disability benefit.
- 8) You provided documentation that indicates that you received \$13,640.00 in “back-pay” from your Social Security Disability benefits in November 2017.
- 9) Your application states that you will not be taking any deductions on your 2018 tax return.
- 10) Your application states, and you confirmed, that you live in Richmond County, NY.
- 11) You testified that you cannot afford the co-pays that are associated with the Essential Plan, and are appealing in order to be found eligible for Medicaid.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable FPL or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Federal Register 8831).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage; therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one -person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly determined you were eligible for the Essential Plan.

The application that was submitted on November 28, 2017, listed an annual expected income of \$20,868.00 and the eligibility determination relied upon that information.

You are in a one-person household for purposes of this analysis. This is because you testified that you expect to file your 2018 income tax return as single and will claim no dependents on that tax return.

The Essential Plan is generally provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size.

On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since an annual household income of \$20,868.00 is 173.03% of the 2017 FPL, NYSOH correctly found you to be eligible for the Essential Plan.

The second issue under review is whether NYSOH properly determined that you were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since \$20,868.00 is 173.03% of the 2017 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You submitted documentation that shows in November 2017 you received the backpay that was due to you from your Social Security Benefit award in the amount of \$13,640.00.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month. Since the documentation you provided shows that you earned \$13,640.00 in November 2017, you do not qualify for Medicaid based on monthly income as of the date of your application.

Since the November 29, 2017 eligibility determination notice properly stated that, based on the information you provided, you were eligible for the Essential Plan and ineligible for Medicaid, it is correct and is AFFIRMED, in part, as it pertains to your eligibility.

Decision

The November 29, 2017 eligibility determination notice is AFFIRMED, in part, as it pertains to your eligibility.

How this Decision Affects Your Eligibility

NYSOH properly determined you were eligible for the Essential Plan.

NYSOH properly determined that you are ineligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
