## **NOTICE OF DISMISSAL – FAILURE TO APPEAR**

On October 3, 2017, NY State of Health (NYSOH) issued a notice of enrollment confirmation, stating that you were enrolled in a Medicaid Managed Care plan, effective November 1, 2017. You appealed this determination.

On January 23, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for February 13, 2018, at 9:00 am.

On February 13, 2018, a Hearing Officer from NYSOH's Appeals Unit called you at 9:00 am. You answered, however, you requested that the hearing be adjourned to a later date. The hearing was adjourned to February 20, 2018 at 1:00 pm.

On February 20, 2018, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 1:00 pm, 1:15 pm, and 1:30 pm, but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

### **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NYSOH will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
