NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On December 4, 2017, NY State of Health (NYSOH) issued a preliminary eligibility determination, stating that you, your spouse and oldest child were remained eligible to enroll in Medicaid, beginning January 1, 2018. You appealed that determination.

A hearing on this matter was scheduled for February 7, 2018, and was dismissed after the Hearing Officer was unable to reach you at the scheduled hearing time.

On February 19, 2018, NYSOH received your request to vacate your appeal. This request was granted, and your case was rescheduled for a hearing.

On February 27, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing your requested was rescheduled to March 19, 2018 at 3:00 PM.

On March 19, 2018 at 3:00 PM, a Hearing Officer from the Appeals Unit of New York State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer wished to pursue your appeal because you, your spouse and oldest child are now enrolled health insurance outside of NYSOH.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
