#### Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you and your spouse were eligible for the Essential Plan, effective January 1, 2018?

Did NY State of Health properly determine that you and your spouse were not eligible for Medicaid?

## **Procedural History**

On December 5, 2017, NYSOH received your updated application for financial assistance for your family. In response to this application, NYSOH prepared a preliminary eligibility determination stating that in part, that you and your spouse were eligible for the Essential Plan, effective January 1, 2018.

That same day, you contacted NYSOH's Account Review Unit and requested an appeal of that eligibility determination insofar as you and your spouse were not found eligible for Medicaid effective December 1, 2017.

On December 6, 2017, NYSOH issued an eligibility determination notice based on your December 5, 2017 application. The notice stated in part, that you and your spouse were eligible to enroll in the Essential Plan, with a \$20.00 monthly premium each, effective January 1, 2018.

Also on December 6, 2017, NYSOH issued an enrollment notice confirming your December 5, 2017 selection of an Essential Plan for you and your spouse. The

notice confirmed that your and your spouse's Essential Plan coverage would begin effective January 1, 2018.

On December 20, 2017, NYSOH issued a notice stating that you and your spouse were eligible for Medicaid for a limited time, effective December 1, 2017. This was because you and your spouse had been granted Aid to Continue pending the outcome of your appeal. You and your spouse were subsequently disenrolled from your Essential Plan and enrolled in a Medicaid Managed Care plan with a plan enrollment start date of December 1, 2017.

On February 12, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- You testified that you expect to file your tax return for 2018 with a tax filing status of married filing jointly. You will claim one dependent on that tax return.
- 2) You applied for coverage and financial assistance for yourself, your spouse, and your child.
- 3) The application that was submitted on December 5, 2017 listed annual household income of \$38,000.00 that your spouse earns from his steady employment. You testified that you do not work due to a long term illness. You testified that \$38,000.00 in expected income for 2018 was correct.
- 4) Your December 5, 2017 application states that you will not be taking any deductions on your 2018 tax return.
- 5) According to your NYSOH account and your testimony, you reside in Suffolk County.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

#### **Essential Plan**

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present noncitizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application that was the 2017 FPL, which is \$20,420.00 for a three-person household (82 Federal Register 8831).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <a href="www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf">www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf</a>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage; therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

#### Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$20,420.00 for a three-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

## Legal Analysis

The first issue under review is whether NYSOH properly determined that you and your spouse were eligible for the Essential Plan, effective December 1, 2017.

The application that was submitted on December 5, 2017 listed an annual household income of \$38,000.00 and the eligibility determination relied upon that information. You testified this amount was correct.

You and your spouse are in a three-person household. You expect to file your 2018 income tax returns as married filing jointly and will claim one dependent.

The Essential Plan is generally provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your December 5, 2017 application, the relevant FPL was \$20,420.00 for a three-person household. Since an annual household income of \$38,000.00 is 186.09% of the 2017 FPL, NYSOH correctly found you and your spouse to be eligible for the Essential Plan.

The second issue under review is whether NYSOH properly determined that you and your spouse were not eligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$20,420.00 for a three-person household. Since \$38,000.00 is 186.09% of the 2017 FPL, NYSOH properly found you and your spouse to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

There is no evidence in your account to show that income for you and your spouse varies from month to month. Therefore, dividing your \$38,000.00 annual income by 12, your household monthly earnings would be \$3,166.67.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,702.00 per month. Therefore, NYSOH properly found that you and your spouse did not qualify for Medicaid based on monthly income as of the date of your December 5, 2017 application.

Since the December 6, 2017 eligibility determination notice properly stated that, based on the information you provided, you and your spouse were eligible for the Essential Plan and not eligible for Medicaid, it was correct and is AFFIRMED.

#### Decision

The December 6, 2017 eligibility determination notice is AFFIRMED.

## How this Decision Affects Your Eligibility

You and your spouse are eligible for the Essential Plan.

You and your spouse are not eligible for Medicaid, and your limited enrollment in that coverage will end.

You case is returned to NYSOH to assist you and your spouse in enrolling a plan for which you are eligible.

# If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
