Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Does the Appeals Unit of NY State of Health (NYSOH) have the authority to review the termination of coverage for your children for a purported non-payment of premiums?

Did NYSOH properly determine that your children's reenrollment in a Child Health Plus plan was effective November 1, 2017?

Procedural History

On June 3, 2017, NYSOH issued a renewal and eligibility determination notice, stating that your children were eligible to enroll in a Child Health Plus (CHP) plan, with a monthly premium of \$9.00 each, effective August 1, 2017.

On June 18, 2017, NYSOH issued an enrollment notice confirming your children's enrollment in CHP plan as of June 16, 2017, with a coverage start date of August 1, 2017.

On September 25, 2017, NYSOH received an update to your application for financial assistance with health insurance.

On October 1, 2017, NYSOH issued an eligibility determination notice stating that each of your children had been found eligible for CHP with a monthly premium of \$9.00, effective November 1, 2017.

On October 26, 2017, NYSOH issued a disenrollment notice stating that your children's coverage in their CHP plan ended effective September 30, 2017, because you did not pay your insurance bill by the payment deadline.

On October 27, 2017, NYSOH issued an enrollment notice stating that your children were reenrolled in a CHP plan as of October 26, 2017, with such coverage beginning November 1, 2017.

December 6, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's CHP plan insofar as it did not begin October 1, 2017.

On February 8, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing your children's CHP plan disenrollment effective September 30, 2017 and their CHP plan re-enrollment date of November 1, 2017.
- 2) Your NYSOH account reflect that your children were enrolled in a CHP plan with an effective start date of August 1, 2017.
- 3) You testified that you may have inadvertently missed a payment due for your children's CHP plan coverage for coverage during the month of September 2017. You further testified that you typically pay your premiums in three-month increments, but that part of your payment may have been applied to an earlier month, leaving their September 2017 premium unpaid.
- 4) Your children were disenrolled from their CHP plan, effective September 30, 2017 for non-payment of premiums.
- 5) You testified that on or about October 25, 2017, you contacted NYSOH or your insurance carrier to inquire on renewing your coverage for the upcoming year when you were advised by a representative that your children no longer had coverage due to non-payment of premium.
- 6) You testified, and your NYSOH account reflects, that you reenrolled your children into a CHP plan on October 26, 2017.
- 7) Your children's Child Health Plus plan start date was November 1, 2017.

- 8) You testified that your children did not have health insurance coverage during the month of October 1, 2017 and, as a result, incurred medical expenses which were not covered by your CHP plan.
- 9) You testified that you wanted your children's enrollment in a CHP plan to begin on October 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (4) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage" (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g.

State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The first issue under review is whether the Appeals Unit of NYSOH has the authority to review the termination of coverage for your children for a purported non-payment of premiums.

The Appeals Unit of NYSOH only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) a failure by NYSOH to provide timely notice of an eligibility determination, and (4) a denial of a for a special enrollment period.

Because the Appeals Unit is not authorized to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether your children were properly terminated for nonpayment of premiums.

Therefore, your appeal of the October 26, 2017 disenrollment notice is **DISMISSED** as a non-appealable issue.

The second issue under review is whether NYSOH properly determined that your children's enrollment in a CHP plan was effective November 1, 2017.

You testified, and your NYSOH account reflects, that you reenrolled your children in a CHP plan on October 26, 2017.

The date on which enrollment in a CHP plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On October 26, 2017, you selected a CHP plan, so your children's enrollment would have properly taken effect on the first day of the following month; that is, on December 1, 2017. However, NYSOH took affirmative steps to reinstate your children's CHP plan coverage a month earlier, on November 1, 2017.

Therefore, the October 27, 2017 enrollment notice stating that your children's enrollment in a CHP plan was effective November 1, 2017, is correct and must be **AFFIRMED**.

Decision

Your appeal of the October 26, 2017 disenrollment notice is **DISMISSED** as a non-appealable issue.

The October 27, 2017 enrollment notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

Your children's CHP plan coverage was terminated effective September 30, 2017, and resumed effective November 1, 2017.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
