NOTICE OF DISMISSAL – FAILURE TO APPEAR

On December 2, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating you were not eligible for retroactive health coverage for the month of October 2017. You appealed that determination.

On January 31, 2018, NYSOH issued a Notice of Hearing to advise you the hearing you requested was scheduled for February 21, 2018, at 3:00 p.m.

On February 21, 2018, a Hearing Officer attempted to call you at the telephone number you provided to NYSOH, [REDACTED], at 3:00 p.m., but you did not answer. The Hearing Officer called the telephone number again at 3:23 p.m. wherein an individual answered and stated that you were not available. The Hearing Officer called the alternate telephone number listed on your account, [REDACTED] at 3:28 p.m., but you did not answer. The Hearing Officer placed one final call to the alternate telephone number listed on your account at 3:40 p.m. wherein an individual answered and stated that she did not know who you were and that it was “the wrong number.” Please contact NYSOH immediately and update the contact information in your account.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days of the Decision Date on this notice. In that writing, you must provide a working phone number that the Hearing Officer can use to contact you for a hearing, or provide assurances that your current phone number will be working in time for the hearing.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

If your request to vacate this dismissal is granted and your phone still is not working by the time of the rescheduled hearing, no further hearings will be scheduled with regard to this appeal.
