## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your eligibility for and enrollment in an Essential Plan was effective January 1, 2018?

## Procedural History

On December 6, 2017, NY State of Health (NYSOH) received your updated application for financial assistance with health insurance. That day, a preliminary eligibility determination was issued stating, in part, that you were eligible for the Essential Plan, effective January 1, 2018.

Also on December 6, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential Plan insofar as it did not begin as of December 1, 2017.

On December 7, 2017, NYSOH issued an eligibility determination notice, based on your December 6, 2017 application, stating in part that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium for a limited time, effective January 1, 2018.

Also on December 7, 2017, NYSOH issued a plan enrollment notice, based on your plan selection on December 6, 2017, stating in part that you were enrolled in an Essential Plan with a \$20.00 monthly premium, and that your plan would start January 1, 2018.

On February 12, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Under oath, you waived your right to timely formal notice of the telephone hearing. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account, you submitted an updated application to NYSOH for financial assistance on December 6, 2017.
- 2) According to your NYSOH account, you were found eligible to enroll in an Essential Plan with a \$20.00 monthly premium, for a limited time, effective January 1, 2018.
- 3) According to your NYSOH account and your testimony, you enrolled in an Essential Plan on December 6, 2017.
- 4) You testified that you wanted your enrollment in an Essential Plan to begin on December 1, 2017, because you have a one-month gap in coverage, between when your employer sponsored health insurance ended and your Essential Plan coverage began, and you have unpaid medical bills from that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

## Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that your eligibility for and enrollment in the Essential Plan was effective January 1, 2018.

You testified, and the record indicates, that you updated your NYSOH application on December 6, 2017. As a result, you were found eligible for the Essential Plan with a \$20.00 monthly premium, for a limited time, as of January 1, 2018. You also selected an Essential Plan for enrollment on December 6, 2017.

Upon making an eligibility determination, NYSOH must notify the applicant and implement any updates in eligibility to the Essential Plan effective the first day of the following month for changes received by NYSOH from the first to the fifteenth of any month. For updates received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month.

In addition, the date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On December 6, 2017, you submitted an application, were re-determined eligible for the Essential Plan, and selected an Essential Plan, so your eligibility for and

enrollment in the Essential Plan properly took effect on the first day of the month following December 1, 2017; that is, on January 1, 2018.

Therefore, NYSOH's December 7, 2017 eligibility determination notice and plan enrollment notice are AFFIRMED because they properly began your eligibility for and enrollment in the Essential Plan on January 1, 2018.

## **Decision**

The December 7, 2017 eligibility determination notice is AFFIRMED.

The December 7, 2017 plan enrollment notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your eligibility for or enrollment in the Essential Plan.

The effective date of your Essential Plan is January 1, 2018.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
