NOTICE OF DISMISSAL – FAILURE TO APPEAR

On December 13, 2017, NY State of Health (NYSOH) issued an eligibility determination notice stating that you, your spouse, and child were eligible for a tax credit up to \$1,125.00 per month and cost-sharing reductions, effective January 1, 2018. You spoke with NYSOH's Account Review Unit and requested an appeal insofar as the amount of financial assistance that your household was determined eligible to receive.

On February 27, 2018, you had a scheduled telephone hearing with NYSOH's Appeals Unit. The Appeals Unit made three attempts to contact you; however, you did not answer.

On March 1, 2018, NYSOH's Appeals Unit issued you a Notice of Dismissal because you failed to appear for your February 27, 2018 telephone hearing. The notice advised you that the dismissal may be vacated if you submitted a written request within 30 days.

On March 5, 2018, you faxed a written request to vacate the dismissal to NYSOH. Your request to vacate the dismissal was granted, and the telephone hearing was rescheduled.

On March 16, 2018, NYSOH issued a Notice of Telephone Hearing, advising you that the hearing you requested was scheduled for April 10, 2018, at 10:00 am.

On April 10, 2018, a Hearing Officer from the NYSOH Appeals Unit attempted to contact you three times between 10:00 am and 10:30 am, using the telephone number you provided to NYSOH. However, there was no answer.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NY State of Health will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
