NOTICE OF DISMISSAL – FAILURE TO APPEAR

On December 13, 2017, NY State of Health (NYSOH) issued an eligibility determination notice stating, in relevant parts, that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium, and your second eldest and youngest children were eligible for Child Health Plus, each with a monthly premium of \$9.00, effective as of January 1, 2018. You requested an appeal insofar as the amount of financial assistance you, your second eldest and youngest children were determined eligible to receive.

On February 15, 2018, NYSOH issued a Notice of Telephone Hearing, advising you that the hearing you requested was scheduled for March 2, 2018, at 3:00 pm.

On March 2, 2018, a Hearing Officer from the NYSOH Appeals Unit attempted to contact you three times between 3:00 pm and 3:30 pm, using the telephone number you provided to NYSOH. However, there was no answer.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NY State of Health will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
