Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly terminate your children's Child Health Plus plan for non-payment of premium effective, November 30, 2017?

Did NYSOH properly determine that your children's reenrollment in their Child Health Plus plan was effective January 1, 2018?

Procedural History

On May 26, 2017, NYSOH issued a notice of eligibility determination, based on your May 25, 2017 application, stating that your children were eligible for Child Health Plus effective July 1, 2017.

Also on May 26, 2017, NYSOH issued a notice of enrollment, stating that your children were enrolled in a Child Health Plus plan, and that this enrollment in the plan would start July 1, 2017.

On December 6, 2017, NYSOH issued a disenrollment notice stating that your children's enrollment in their Child Health Plus plan was terminated, effective November 30, 2017, because a premium payment had not been received by the health plan.

On December 7, 2017, NYSOH received your children's updated application for health insurance.

On December 8, 2017, NYSOH issued a notice of eligibility determination, based on your December 7, 2017 application, stating that your children were eligible to enroll in Child Health Plus, effective January 1, 2018.

Also on December 8, 2017, NYSOH issued a notice of enrollment, based on your plan selection on December 7, 2017, stating that your children were enrolled in a Child Health Plus plan and that coverage would start on January 1, 2018.

On December 13, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's Child Health Plus plan insofar as they did not have coverage for the month of December 2017.

On March 1, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are only appealing your children's disenrollment from their Child Health Plus plan for the month of December 2017.
- 2) Your children were enrolled into a Child Health Plus plan, effective July 1, 2017.
- 3) You testified that you were one day late with payment in December 2017. You further testified that when you called your children's Child Health Plus plan in order to make the December 2017 premium payment one day late, you were advised that your children had already been disenrolled from their coverage.
- 4) Your children were disenrolled from their Child Health plus plan, effective November 30, 2017.
- 5) You testified that when you became aware that your children had been disenrolled you contacted NYSOH to reenroll them.
- 6) On December 7, 2017, NYSOH received your updated application and Child Health Plus plan selection.
- 7) You testified that you are requesting that your children be reenrolled in their Child Health Plus plan for the month of December 2017 because they have outstanding medical bills for that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) an eligibility determination for an exemption; (4) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (5) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Child Health Plus

A child who meets the eligibility requirements for Child Health Plus may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (NY Public Health Law § 2511(2)(a)(iii)).

To be eligible for Child Health Plus, the child:

- Must be under 19 years of age;
- Must be a New York State Resident;
- Must not have other health insurance coverage; and
- Must not be eligible for, or enrolled in, Medicaid

(NY Public Health Law § 2511(2)(a)-(e)).

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the Child Health Plus premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of

children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly terminated your children’s Child Health Plus plan for non-payment of premium effective, November 30, 2017.

On May 25, 2017 your children were enrolled in a Child Health Plus plan, effective July 1, 2017.

You testified that in December 2017 you were late with your children’s premium payment.

On December 6, 2017, NYSOH issued a notice stating that your children were disenrolled from their Child Health Plus plan for non-payment of premiums, effective November 30, 2017.

NYSOH Appeals Unit only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) an eligibility determination for an exemption, (4) a failure to provide timely notice of an eligibility determination and (5) a denial of a special enrollment period.

Since the Appeals Unit is not given the authority to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether or not your children were properly terminated from their Child Health Plus plan for non-payment of premiums. Therefore, your appeal of the December 6, 2017 disenrollment notice is **DISMISSED** as a non-appealable issue.

The second issue is whether NYSOH properly determined that your children’s reenrollment in their Child Health Plus plan was effective January 1, 2018.

You contacted NYSOH on December 7, 2017 to reenroll your children into their Child Health Plus plan.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

As you contacted NYSOH to reenroll your children into a Child Health Plus plan on December 7, 2017, their reenrollment should have taken effect the first day of the first following month after December 7, 2017; that is, on January 1, 2018.

Therefore, the December 8, 2017 enrollment confirmation notice stating that your children's reenrollment in their Child Health Plus plan was effective January 1, 2018 is AFFIRMED.

Decision

Your appeal of the insurer's termination of your children's enrollment in their Child Health Plus plan for non-payment of premiums, effective November 30, 2017, is DISMISSED as a non-appealable issue.

The December 8, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your children's eligibility.

Your children's reenrollment in their Child Health Plus plan was effective January 1, 2018.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the

dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
