Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that you were eligible for Medicaid effective December 1, 2017?

Procedural History

On December 12, 2017, you submitted two applications for health insurance through NYSOH. The first indicated that you were not requesting financial assistance and that you did not need health insurance. The second requested financial assistance, indicated that you did need health insurance, and that you did not have coverage in place already.

On December 13, 2017, NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid, effective December 1, 2017.

On December 14, 2017, you updated your NYSOH account and again submitted two applications. The first requested financial assistance and the second declined such assistance; however, both indicated that you did not need health insurance.

No written notices were issued regarding these last applications.

Also on December 14, 2017, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you did not want Medicaid

and wanted to be retroactively disenrolled from Medicaid fee-for-service coverage for the month of December 2017.

On February 28, 2018, you had a hearing scheduled with a Hearing Officer from NYSOH's Appeals Unit. On that date, the Hearing Officer was unable to reach you after three attempts at the telephone number in your account. Accordingly, your appeal was dismissed for failure to appear for your scheduled telephone hearing. Subsequently, you submitted a written request to vacate the dismissal and this request was granted and a new hearing was rescheduled.

On May 8, 2018, you had the rescheduled telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account, you submitted two, completed applications for health insurance with NYSOH on December 12, 2017. The first declined financial assistance and stated you did not need health insurance, and the second requested financial assistance and stated that you did need health insurance.
- 2) According to your NYSOH account and your testimony, you will not be filing a tax return, and you have no income and no dependents. You testified that you are financially supported by friends and/or family.
- 3) According to your testimony, when you submitted the December 12, 2017 application, you already had private insurance with [REDACTED] and were only interested in seeing if you could obtain a lower cost health insurance starting January 1, 2018.
- 4) According to your NYSOH account, based on the December 12, 2017 application, you were determined eligible for Medicaid, effective December 1, 2017.
- 5) You testified that you never asked to be enrolled in Medicaid; you were simply seeking information.
- 6) You testified that you want to be disenrolled from Medicaid effective December 1, 2017 and that there be no record of your enrollment in Medicaid.
- 7) According to your NYSOH account and your testimony, you reside in [REDACTED].

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

An individual will be enrolled or remain in their Medicaid plan with limited exceptions, including entering prison or another facility that provides medical care, lack of state residence, failing to provide a valid Social Security number, or having third party health insurance (NY Social Services Law § 366(4)(c)).

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010, 13ADM-03(III)(F)).

Legal Analysis

The issue is whether NYSOH properly determined that you were eligible for Medicaid, effective December 1, 2017.

The second application that was submitted on December 12, 2017 requested financial assistance and stated that you did not need health insurance. It listed an annual household income of \$0.00. As a result, you were found eligible for Medicaid.

However, you testified credibly that you did not agree to be enrolled in Medicaid, and that you already were enrolled in health insurance outside of NYSOH. You stated that you were simply calling NYSOH to see if you could obtain a lower cost health insurance starting January 1, 2018.

There is nothing in the record that would contradict your testimony that you never agreed to enroll in coverage when you applied for financial assistance. This is

supported by the other applications that were submitted on or near the application that resulted in coverage through Medicaid.

Since the December 12, 2017 eligibility determination notice was based on an inaccurate information and the enrollment in Medicaid was started without your consent, the December 14, 2017 is RESCINDED.

Decision

The December 13, 2017 eligibility determination notice is RESCINDED; your enrollment in Medicaid is also rescinded.

How this Decision Affects Your Eligibility

Your enrollment in Medicaid is rescinded.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the
