Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that were eligible to receive up to \$79.00 per month in advance premium tax credit (APTC), effective January 1, 2018?

Procedural History

On December 12, 2017, you applied for health insurance with financial assistance through NYSOH.

On December 13, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to receive up to \$79.00 in APTC, effective January 1, 2018.

On December 15, 2017, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you were not eligible for an increased amount of APTC.

On February 21, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open until March 7, 2018, to allow you time to submit supporting documents.

On March 1, 2018, NYSOH received your supporting documents. The documents were made part of the record as Appellant's Exhibit #1 and the record was closed.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You are seeking health insurance for yourself.
- You testified that you expect to file your tax return for 2018 with a tax filing status of married filing jointly and will not claim any dependents.
- 3) The application submitted on December 12, 2017, listed your expected 2018 gross annual household income as \$54,000.00 from income spouse earns from employment. That application lists your spouse's gross monthly salary as \$4,500.00. You testified that these amounts are correct.
- 4) You testified, and provided documentation to show, that your spouse works and sends you approximately \$2,500.00 per month. You testified that you believe the \$2,500.00 per month that your spouse sends you, rather than the total \$4,500.00 per month he earns, should be used in determining your eligibility for financial assistance because it more accurately reflects the amount of income available to you.
- 5) Your application states that you will not claim any dependents on that tax return.
- 6) Your application states that you will not be taking any deductions on your 2018 tax return.
- 7) Your application states that you live in NY.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a qualified health plan, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 26 CFR § 1.36B-2, 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

 the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2018 is set by federal law at 2.01% to 9.56% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3, IRS Rev. Proc. 2017-36).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2017 FPL, which is \$ 16,240.00 for a two-person household (82 Federal Register 8831).

For annual household income in the range of at least 300% but less than 400% of the 2017 FPL, the expected contribution in 2018 is 9.56% of the household income (26 CFR § 1.36B-3(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2017-36).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term "modified adjusted gross income" means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

"Adjusted gross income" means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of finds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income (id.).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were eligible for up to \$79.00 per month in APTC.

The application that was submitted on December 12, 2017, listed an annual household income of \$54,000.00, and the eligibility determination relied upon that information.

During the hearing, you testified that the amount you provided in your application, \$54,000.00, was correct. However, you testified that your spouse works and only sends you \$2,500.00 per month, not the full \$4,500.00 he earns. You asked that your total gross income of \$30,000.00 (the result of \$2,500.00 multiplied by 12 months) be considered your total gross income when calculating your annual household income.

The Internal Revenue Service rules requires gross federal taxable income to be used when calculating adjusted gross income. The portion of money you receive from your spouse may not be used to calculate your modified adjusted gross income for APTC purposes since your household's gross federal taxable income \$54,000.00 per year. Therefore, NYSOH correctly determined your household income to be \$54,000.00.

That application also reflects that you expect to file your 2018 income tax return as married filing jointly and will not claim any dependents on that tax return. Therefore, you are in a two-person household for purposes of this analysis.

You reside in where the second lowest cost silver plan available for an individual through NYSOH costs \$509.30 per month.

An annual income of \$54,000.00 is 332.51% of the 2017 FPL for a two-person household. At 332.51% of the FPL, the expected contribution to the cost of the health insurance premium is 9.56% of income, or \$430.20 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$509.30 per month) minus your expected contribution (\$430.20 per

month), which equals \$79.10 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$79.00 per month in APTC.

Since the December 13, 2017 eligibility determination notice properly stated that, based on the information you provided, you were eligible for up to \$79.00 per month in APTC, it is correct and is AFFIRMED.

Decision

The December 13, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You were properly determined eligible for \$79.00 in APTC in 2018.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
