NOTICE OF DISMISSAL

On December 19, 2017, NY State of Health (NYSOH) issued a plan enrollment notice, stating that you were enrolled in a full pay qualified health plan, effective February 1, 2018. You appealed this determination.

On February 1, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for February 21, 2018, at 10:00 a.m..

A Hearing Officer called you at 10:00 a.m. on February 21, 2018. Although you answered the call, you stated you were no longer interested in pursuing the appeal because your coverage had already started on February 1, 2018. You further stated that you requested the appeal in December 2017, and it makes no sense that you would have to wait so long for a hearing date. You refused to be sworn in so that you could withdrawal your appeal.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
