Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your oldest child's enrollment in his Child Health Plus plan was effective February 1, 2018?

Procedural History

On December 18, 2017, NY State of Health (NYSOH) received your oldest child's application for financial assistance with his health insurance.

That day, a preliminary eligibility determination was prepared stating your oldest child was eligible for Child Health Plus for a cost of \$9.00 per month, effective February 1, 2018. You enrolled him in a Child Health Plus plan that day with a February 1, 2018 start date.

On December 18, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's Child Health Plus plan insofar as it did not begin December 1, 2017.

On December 19, 2017, NYSOH issued an eligibility determination notice, based on your December 18, 2017 application, stating that your child was eligible to enroll in Child Health Plus with a \$9.00 monthly premium, effective February 1, 2018.

Also on December 19, 2017, NYSOH issued a plan enrollment notice, based on your plan selection on December 18, 2017, stating that your child was enrolled in

a Child Health Plus plan, and that this enrollment in the plan would start February 1, 2018.

On February 21, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing your child's eligibility.
- 2) You submitted an application to NYSOH for financial assistance for your child on December 18, 2017 online.
- 3) According to your NYSOH account and testimony, you enrolled your oldest child into a Child Health Plus plan on December 18, 2017 after applying online and calling in to NYSOH.
- 4) You testified your child was previously enrolled in Medicaid through your local County until August 1, 2017.
- 5) You testified that you need your child's Child Health Plus plan to begin on December 1, 2017, because you incurred medical bills at [REDACTED] and [REDACTED] for him in those months.
- 6) You testified you did not have any issues with your application.
- 7) Your application states your child resides with you in Broome County, NY.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer

resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your child's enrollment in his Child Health Plus plan was effective February 1, 2018.

You testified that you contacted NYSOH on December 18, 2017, after applying online and enrolled your child into a Child Health Plus plan.

Your child was previously enrolled in Medicaid through your local County until August 1, 2017, and you added him as applying to insurance with a NYSOH application first on December 18, 2017. You explained that you need your child's Child Health Plus plan to begin on December 1, 2017, because you incurred medical bills at [REDACTED] and [REDACTED] for him in December 2017 and January 2018. You testified you did not have any issues with your application.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you applied for Child Health Plus and enrolled your child in a Child Health Plus plan as of December 18, 2017, the earliest the plan could take effect is the first day of the second month following December 2017; that is, on February 1, 2018. There is no mechanism in the law or by policy to allow your child's coverage to be backdated to December 1, 2017.

Therefore, the December 19, 2017 plan enrollment notice stating that your child's enrollment in his Child Health Plus plan was effective February 1, 2018, is correct and must be AFFIRMED.

Decision

The December 19, 2017 plan enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

The effective date of your child's Child Health Plus plan through NYSOH is February 1, 2018.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
