Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your coverage under the MVP Premier Silver 2 ST3PCP INN Dep25 Telemedicine Wellness plan was effective February 1, 2018?

Procedural History

On November 17, 2017, NYSOH redetermined your eligibility for financial assistance with health insurance.

On November 18, 2017, NYSOH issued an eligibility determination notice stating that you were eligible for an advance premium tax credit (APTC) of up to \$64.00 per month and, if you selected a silver-level plan, eligible for cost-sharing reductions (CSR), effective January 1, 2018.

On November 19, 2017, NYSOH issued an enrollment notice confirming your selection of MVP Premier Plus Gold 1 NS INN Dep25 Acupuncture Telemedicine Wellness 3PCP (MVP Premier Plus Gold) as of November 18, 2017, with such coverage beginning January 1, 2018, at a monthly premium rate of \$537.47 after not applying any of the available APTC.

On December 15, 2017, NYSOH received an update to your application for financial assistance with health insurance.

On December 16, 2017, NYSOH issued an eligibility determination notice stating that you were eligible for an APTC of up to \$59.00 per month and, if you selected a silver-level plan, eligible for CSR, effective January 1, 2018.

Also on December 16, 2017, NYSOH issued an enrollment notice confirming your enrollment in MVP Premier Plus Gold as of December 15, 2017, with such coverage beginning effective January 1, 2018, at a monthly premium rate of \$537.47.

On December 19, 2017, NYSOH issued an enrollment notice confirming your selection of MVP Premier Silver 2 ST3PCP INN Dep25 Telemedicine Wellness (MVP Premier Silver) as of December 15, 2017, with such coverage beginning effective February 1, 2017, at a premium rate of \$426.76 after applying the \$59.00 APTC. However, your NYSOH enrollment details reflect that you requested such a change of plans on December 18, 2017.

On or about December 19, 2017, you spoke to NYSOH's Account Review Unit and appealed insofar as your MVP Premier Silver plan did not begin effective January 1, 2018.

On February 22, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record support the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on December 15, 2017.
- 2) You enrolled in the MVP Premier Plus Gold plan on December 15, 2017, with such coverage beginning on January 1, 2018 at a premium rate of \$537.47 after not applying any of the available APTC.
- 3) You testified that you attempted to update your enrollment to the MVP Premier Silver plan on December 15, 2017 after including your Social Security income in your application. You further testified that while you selected the plan, you inadvertently did not confirm your change of plan at that time.
- 4) Your NYSOH account enrollment details reflect that you switched your enrollment from the MVP Premier Plus Gold plan to the MVP Premier Silver plan on December 18, 2017.

- 5) You testified that you were seeking for your MVP Premier Silver plan enrollment to begin on January 1, 2018, in an effort to recoup the approximate \$100.00 premium difference between the two plans for coverage during the month of January 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your coverage under the MVP Premier Silver plan began effective February 1, 2018.

You testified that you attempted to update your enrollment to the MVP Premier Silver plan on December 15, 2017 after including your Social Security income in your application. You further testified that while you selected the MVP Premier Silver plan at that time, you inadvertently did not confirm your change of plan.

Your NYSOH account enrollment details reflect that you switched your enrollment from the MVP Premier Plus Gold plan to the MVP Premier Silver plan on December 18, 2017.

The date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the sixteenth to the last day of any month day of a month goes into effect on the first day of the second following month.

Therefore, NYSOH's December 19, 2017 enrollment notice is **AFFIRMED** because it properly began your enrollment in the MVP Premier Silver plan effective February 1, 2018.

Decision

The December 19, 2017 enrollment notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

Your enrollment in the MVP Premier Silver plan began effective February 1, 2018.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
