Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you and your spouse were eligible to receive up to \$684.00 per month in advance payments of the premium tax credit, effective February 1, 2018?

Did NY State of Health properly determine that you and your spouse were eligible for cost-sharing reductions?

Did NY State of Health properly determine that you and your spouse were not eligible for the Essential Plan?

Did NY State of Health properly determine that you and your spouse were not eligible for Medicaid?

Did NY State of Health properly determine that your children were eligible to enroll in Child Health Plus with a \$15.00 per month premium, effective February 1, 2018?

Did NY State of Health properly determine that your children were not eligible for Medicaid?

Procedural History

On December 20, 2017, you applied for health insurance and financial assistance through NY State of Health (NYSOH).

That day, a preliminary eligibility determination was prepared stating that you and your spouse were eligible to receive up to \$684.00 in advance payments of the premium tax credit (APTC) and cost-sharing reductions, effective February 1, 2018. That preliminary eligibility determination also stated that your children were eligible for Child Health Plus with a \$15.00 monthly premium, effective February 1, 2018.

Also on December 20, 2017, you spoke to NYSOH's Account Review Unit and appealed that preliminary eligibility determination notice insofar as you, your spouse, and your children were not eligible for Medicaid.

On December 21, 2017, NYSOH issued an eligibility determination notice, based on your December 20, 2017 application, stating that you and your spouse were eligible to receive up to \$684.00 in APTC, as well as cost-sharing reductions if you enrolled in a silver level qualified health plan, both effective February 1, 2018. That notice also stated that you and your spouse were not eligible for the Essential Plan and Medicaid because your annual household income was over the allowable income limits for those programs.

Additionally, the December 21, 2017 eligibility determination notice stated that your children were eligible for Child Health Plus with a \$15.00 monthly premium, effective February 1, 2018. The notice further stated that your children were not eligible for Medicaid because your income of \$57,556.00 was over the allowable limit for that program.

On January 6, 2018, NYSOH issued a notice stating that you, your spouse, and your children were eligible for Medicaid for a limited time, effective February 1, 2018. This was because you, your spouse, and your children had been granted Aid to Continue pending the outcome of your appeal.

On January 6, 2018, NYSOH issued an enrollment confirmation notice stating that you, your spouse, and your children were enrolled in a Medicaid Managed Care plan effective February 1, 2018.

On February 6, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open up to February 21, 2018, to allow you time to submit supporting documents.

On February 19, 2018, NYSOH received the supporting documents requested by upload. The documents were incorporated into the record as Appellant's Exhibit #1. The record was closed that same day.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your tax return for 2017 with a tax filing status of married filing jointly. You will claim your two children as dependents on that tax return.
- 2) The application that was submitted on December 20, 2017 listed an annual household income of \$57,556.00, consisting of \$18,000.00 you earn from self-employment and \$39,556.00 your spouse receives in income from employment. You testified that you believed this amount was correct.
- 3) Your application states that your children are [REDACTED]; however, you testified that the birthdate year was incorrect on your application and your children are actually [REDACTED]
- 4) On February 19, 2018, you uploaded documentation, that your monthly income for December 2017 was \$1,920.00. You also uploaded pay stubs from your spouse's employment showing that his monthly gross income for December 2017 was \$2,736.00.
- 5) You testified that your spouse did not earn additional income from [REDACTED] in the month of December 2017.
- 6) Your application states that you will not be taking any deductions on your 2017 tax return. However, you testified that you will take a student loan interest deduction of \$1,000.00.
- 7) Your application states that you live in Columbia County.
- 8) You testified that you would like you, your spouse, and your children to be eligible for Medicaid.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a qualified health plan, and (3) is not otherwise eligible

for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 26 CFR § 1.36B-2, 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2018 is set by federal law at 2.01% to 9.56% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3, IRS Rev. Proc. 2017-36).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2017 FPL, which is \$24,600.00 for a four-person household (82 Federal Register 8831).

For annual household income in the range of at least 200% but less than 250% of the 2017 FPL, the expected contribution is between 6.34% and 8.10% of the household income (26 CFR § 1.36B-3(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2017-36).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Cost-Sharing Reductions

Cost-sharing reductions are available to a person who (1) is eligible to enroll in a qualified health plan through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year

for which coverage is requested, and (4) is enrolled in a silver-level qualified health plan (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable FPL or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application that was the 2017 FPL, which is \$24,600.00 for a four-person household (82 Fed. Reg. 8831).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage; therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$24,600.00 for a four-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Child Health Plus

Child Health Plus (CHP) is a sliding-scale-premium program for children who are in a household that is over income for regular Medicaid (see New York Public Health Law (NY PHL) § 2510 et seq. and 42 USC § 1397aa). Eligibility rules are set out in NY PHL § 2511(2), as well as in the NYS Department of Health 2008-2012 Contract and Plan Manual.

A child who meets the eligibility requirements for CHP may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (NY PHL § 2511(2)(a)(iii)). To be eligible to enroll in CHP with subsidy payments, a child must not be “eligible for medical assistance”; that is, must not be eligible for Medicaid (NY PHL § 2511(2)(b)).

The amount of the premium payment, if any, that must be made on behalf of a child who enrolls in a CHP plan depends upon the child’s family household income (NY PHL § 2510(9)(d)). No payments are required for eligible children whose family household income is less than 160% of the FPL (NY PHL § 2510(9)(d)(1)). If the family household income is 160% or higher, premiums range from \$9.00 per month to \$60.00 per month (NY PHL § 2510(9)(d)).

The CHP premium is \$15.00 per month for a child whose family household income is between 223% and 250% of the FPL, but no more than \$54.00 per month per family (NY PHL § 2510(9)(d)(iii)).

In an analysis of Child Health Plus eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which was \$24,600.00 for a four-person household (82 Federal Register 8831).

Medicaid for Children

A child who is under one year of age is eligible for Medicaid if he or she meets the non-financial criteria and has a household modified adjusted gross income that falls at or below 223% of the FPL for the applicable family size. (42 CFR §

435.118(c); New York State Department of Social Services Administrative Directive 13 OHIP/ADM-03).

In the case of an individual who expects to file a tax return and does not expect to be claimed by another taxpayer, the household consists of the taxpayer and all persons whom such individual expects to claim as a tax dependent (42 CFR § 435.603(f)(1)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which was \$24,600.00 for a four-person household (82 Federal Register 8831).

Legal Analysis

The first issue is whether NYSOH properly determined that you and your spouse were eligible for up to \$684.00 per month in APTC, effective February 1, 2018.

The application that was submitted on December 20, 2017 listed an annual household income of \$57,556.00 and the eligibility determination relied upon that information.

You and your spouse are in a four-person household. You expect to file your 2017 income tax return as married filing jointly and will claim two dependents on that tax return.

You reside in Columbia County, where the second lowest cost silver plan available for a couple through NYSOH costs \$1045.24 per month.

An annual income of \$57,556.00 is 233.97% of the 2017 FPL for a four-person household. At 233.97% of the FPL, the expected contribution to the cost of the health insurance premium is 7.54% of income, or \$361.64 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for couple in your county (\$1045.24 per month) minus your expected contribution (\$361.64 per month), which equals \$683.59 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you and your spouse to be eligible for up to \$684.00 per month in APTC.

The second issue is whether you and your spouse were properly determined eligible for cost-sharing reductions. Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$57,556.00 is 233.97% of the applicable FPL, NYSOH correctly found you and your spouse to be eligible for cost sharing reductions.

The third issue under review is whether NYSOH properly determined you and your spouse were ineligible for the Essential Plan.

The Essential Plan is generally provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$24,600.00 for a four-person household. Since an annual household income of \$57,556.00 is 233.97% of the 2017 FPL, NYSOH correctly found you and your spouse to be ineligible for the Essential Plan.

The fourth issue is whether NYSOH properly determined that you and your spouse were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$24,600.00 for a four-person household. Since \$57,556.00 is 233.97% of the 2017 FPL, NYSOH properly found you and your spouse to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

On February 19, 2018, you uploaded documentation, that your monthly income for December 2017 was \$1,920.00. You also uploaded pay stubs from your spouse's employment showing that his monthly income for December 2017 was \$2,736.00. You testified that your spouse did not earn additional income from freelance work in the month of December 2017.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$2,829.00 per month. Since the information you provided shows a household income of \$4,656.00 for December 2017, you and your spouse do not qualify for Medicaid based on monthly income as of the date of your application.

Since the December 21, 2017, eligibility determination notice properly stated that, based on the information you provided, you and your spouse were eligible for up to \$684.00 per month in APTC, eligible for cost-sharing reductions, ineligible for the Essential Plan and ineligible for Medicaid, it is correct and is AFFIRMED, in part.

The fifth issue under review is whether NYSOH properly determined that your children were eligible to enroll in Child Health Plus with a \$15.00 per month premium.

According to the record, you expect to file a joint federal income tax return for the 2017 tax year and claim your two children as dependents. Therefore, your children are in a four-person household.

In your December 21, 2017 application, you attested to an expected household income of \$57,556.00. Your application states that your children are [REDACTED]; however, you testified that the birthdate year was incorrect on your application and your children are actually [REDACTED]

A child is eligible to enroll in Child Health Plus if they meet the non-financial requirements, are not eligible for Medicaid, and have a household income below 400% of the FPL. Households with an income between 223% and 250% of the FPL are responsible for a \$15.00 per month Child Health Plus premium payment. On the date of your application, the relevant FPL was \$24,600.00 for a four-person household. Since \$57,556.00 is 233.97% of the 2017 FPL, NYSOH properly found your children to be eligible for Child Health Plus with a \$15.00 per month premium payment.

The sixth issue is whether NYSOH properly determined that your children were not eligible for Medicaid.

Medicaid can be provided through NYSOH to children between the ages of one and nineteen who meet the non-financial requirements and have a household modified adjusted gross income (MAGI) that is at or below 154% of the FPL for the applicable family size. Since \$57,556.00 is 233.97% of the 2017 FPL for a four-person household, NYSOH properly found your children to be not eligible for Medicaid.

As discussed above, a person can also be eligible for Medicaid based on monthly income.

To be eligible for Medicaid on a monthly basis, your children would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$3,157.00 per month. Since the information you provided shows a household income of \$4,656.00 for December 2017, your children do not qualify for Medicaid based on monthly income as of the date of your application.

Since the December 21, 2017 eligibility determination properly stated that, based on the information you provided, your children were eligible for Child Health Plus with a \$15.00 per month premium and ineligible for Medicaid, it is correct and is **AFFIRMED**.

Decision

The December 21, 2017 eligibility determination notice is AFFIRMED.

Effective Date of this Decision: March 2, 2018

How this Decision Affects Your Eligibility

You and your spouse remain eligible for up to \$684.00 in APTC.

You and your spouse are eligible for cost-sharing reductions.

You and your spouse are ineligible for the Essential Plan.

You and your spouse are ineligible for Medicaid.

Your children remain eligible for Child Health Plus with a \$15.00 per month premium.

Your children are ineligible for Medicaid.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
