## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that your child's enrollment in the Essential Plan began effective February 1, 2018?

Did NYSOH properly determined that your enrollment in your qualified health plan began effective February 1, 2018?

## Procedural History

On December 10, 2017, NYSOH received an update to your application for financial assistance with health insurance.

On December 11, 2017, NYSOH issued an eligibility determination notice stating that you were newly eligible to purchase a qualified health plan (QHP) at full cost, effective January 1, 2018. The notice also stated that your child was eligible for an advance premium tax credit (ATPC) of up to \$25.00 per month, effective January 1, 2018.

On December 21, 2017, NSYOH received an additional update to your application for financial assistance with health insurance. In response to this application, NYSOH prepared a preliminary eligibility determination stating that you were purchase a QHP at full cost, effective February 1, 2018, and you're your child was eligible to enroll in the Essential Plan with a \$20.00 premium per month, effective February 1, 2018

Also on December 21, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of you and your child's respective enrollment start dates, seeking a start date of January 1, 2018, rather than February 1, 2018.

On December 22, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to purchase a QHP at full cost, effective February 1, 2018. The notice also stated that your child was eligible to enroll in the Essential Plan with a \$20.00 premium per month, effective February 1, 2018.

Also on December 22, 2017, NYSOH issued an enrollment notice confirming your selection of a QHP for your coverage as of December 21, 2017, and your selection of an Essential Plan for your child's coverage as of December 21, 2017. In each case, your respective enrollment in those health plans was found to begin effective February 1, 2018.

On February 27, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record support the following findings of fact:

- 1) You submitted your initial application to NYSOH for financial assistance on December 10, 2017.
- 2) You testified that you had attempted to select health plans for you and your child on December 10, 2017, but had technical issues with your NYSOH account that prevented you from doing so. You further testified that you did not take any additional steps to contact NYSOH to select a plan at that time.
- 3) You submitted a revised application to NYSOH for financial assistance on December 21, 2017.
- 4) You testified, and your NYSOH account reflects, that on December 21, 2017, you selected a QHP for your enrollment, and selected an Essential Plan for your child's enrollment.
- 5) You testified that you need you and your child's respective health plans' coverage to begin on January 1, 2018 because of medical expenses you incurred during the month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

### Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## **Legal Analysis**

The first issue under review is whether NYSOH properly determined that your child's enrollment in the Essential Plan began effective February 1, 2018.

You testified, and the record indicates, that you updated your NYSOH application on December 21, 2017. As a result, your child was found eligible for the Essential Plan as of December 21, 2017, and enrolled into a plan that day.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is

selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On December 21, 2017, you selected an Essential Plan, so your child's enrollment properly took effect on the first day of the second month following December 2017; that is, on February 1, 2018.

The second issue under review is whether NYSOH properly determined that your enrollment in your QHP began effective February 1, 2018.

The record shows that December 21, 2017 you updated the information in your NYSOH account and submitted a request to enroll in a QHP. On December 22, 2017, NYSOH issued an enrollment notice stating that your enrollment in your QHP was effective February 1, 2018.

When an individual changes information in their application after the 15th of any month, NYSOH will make the redetermination that results from the change effective the first day of the second following month. Additionally, the date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is after the fifteenth day of a month goes into effect on the first day of the second following month.

On December 21, 2017, you selected your QHP, so your enrollment properly took effect on the first day of the second month following December 2017; that is, on February 1, 2018.

Therefore, NYSOH's December 22, 2017 enrollment notice is **AFFIRMED** because it properly began you and your child's enrollment in your respective health plans, effective February 1, 2018.

It is noted that although you stated you were unable to select health plans on December 10, 2017 due to technical difficulties, there is no indication in NYSOH's record that you reported any problem with enrolling, and you did not explain why you did not attempt to enroll again until December 21, 2017. Therefore, the Appeals Unit finds that there is no basis to backdate the plans' start dates based on a defect on your account.

## **Decision**

The December 22, 2017 enrollment notice is **AFFIRMED**.

## **How this Decision Affects Your Eligibility**

Your QHP coverage began effective February 1, 2018.

Your child's Essential Plan coverage began effective February 1, 2018.

## **If You Disagree with this Decision (Appeal Rights)**

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
