NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On December 27, 2017, NY State of Health (NYSOH) issued a plan enrollment notice, stating that you and your spouse were disenrolled from your Blue Cross Gold qualified health plan, effective January 31, 2018 and were enrolled in a Fidelis Gold qualified health plan, effective February 1, 2018. You appealed these determinations.

On April 27, 2018, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you and your spouse under oath.

While under oath, your spouse identified herself and stated that you were no longer interested in pursuing your appeal because you and your spouse were unsure whether Fidelis would cover the medical expenses for the month of January 2018.

Your spouse therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
