Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you and your spouse were eligible for the Essential Plan?

Did NY State of Health properly determine that you and your spouse were not eligible for Medicaid?

Procedural History

On December 26, 2017, you applied for health insurance and financial assistance through NY State of Health (NYSOH).

That day, a preliminary eligibility determination was prepared stating that you and your spouse were eligible for the Essential Plan, effective February 1, 2018.

On December 27, 2017, you spoke to NYSOH's Account Review Unit and appealed that preliminary eligibility determination notice insofar as you and your spouse did not have coverage as of January 1, 2018.

On December 27, 2017, NYSOH issued an eligibility determination notice stating that you and your spouse were eligible for the Essential Plan effective February 1, 2018. That notice also stated that you and your spouse were not eligible for Medicaid because your annual household income was over the allowable income limit for that program.

Also on December 27, 2017, NYSOH issued an enrollment confirmation notice stating that you and your spouse were enrolled in an Essential Plan, effective February 1, 2018.

On February 22, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. During the hearing, you waived your right to the 15-day formal notice of hearing. You also clarified that you are seeking through this appeal is for you and your spouse to be found eligible for Medicaid. The record was developed during the hearing and held open up to March 9, 2018, to allow you time to submit supporting documents.

On February 25, 2018, NYSOH received your supporting documents by fax. The documents were incorporated into the record as Appellant's Exhibit #1 and the record was closed.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your tax return for 2018 with a tax filing status of married filing jointly. You will claim no dependents on that tax return.
- 2) You are seeking insurance for you and your spouse.
- 3) The application that was submitted on December 26, 2017 listed annual expected household income of \$23,114.46, consisting of \$11,114.46 you earn from your employment and \$12,000.00 that you get from additional income.
- 4) You testified that you are paid on a bi-weekly, part-time basis and that your income varies.
- 5) You testified that due to unforeseen medical issues you and your spouse have been out of work since December 2017.
- 6) You provided a print out of your earnings statements showing that in December 2017, you received two paychecks for a total gross pay amount of \$957.16.
- 7) You provided your spouse's earning and expenses report for his business showing that for the month of December 2017 he received \$0.00 in gross income from his business.

- 8) Your application states and you confirmed that you will not be taking any deductions on your 2017 tax return.
- 9) Your application states that you live in Suffolk County.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable FPL or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application that was the 2017 FPL, which is \$16,240.00 for a two-person household (82 Fed. Reg. 8831).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage; therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$16,240.00 for a two-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly determined you and your spouse were eligible for the Essential Plan.

The application that was submitted on December 26, 2017 listed annual household income of \$23,114.46, consisting of \$11,114.46 you earn from your employment and \$12,000.00 that you get from additional income. The eligibility determination relied upon that information.

You are in a two-person household. You expect to file your 2017 income taxes as married filing jointly and will claim no dependents on that tax return. Your application states and you confirmed that you will not be taking any deductions on your 2017 tax return.

The Essential Plan is generally provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,240.00 for a two-person household. Since an annual household income of \$23,114.46 is 142.33% of the 2017 FPL, NYSOH properly found you and your spouse to be eligible for the Essential Plan based on the information you provided to NYSOH.

The second issue is whether NYSOH properly determined that you and your spouse were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,240.00 for a two-person household. Since \$23,114.16 is 142.33% of the 2017 FPL, NYSOH properly found you and your spouse to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

Since the December 27, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for the Essential Plan and ineligible for Medicaid, it is correct and is AFFIRMED.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You testified that you are paid on a bi-weekly, part-time basis and that your income varies. You submitted a pay summary from your employer that shows in December 2017 you received \$957.16. You also submitted an earning and expense statement from your spouse that shows in December 2017 he received \$0.00.

Therefore, your case is RETURNED to NYSOH to redetermine you and your spouse's eligibility for financial assistance on a monthly basis as of your December 26, 2017 application for health insurance. NYSOH is directed to determine your and your spouse's eligibility based on a household of two people, residing in Suffolk County with a monthly income of \$957.16. Any redetermination made on the basis of this information is to be effective as if the determination was made on December 26, 2017.

Decision

The December 27, 2017 eligibility determination notice is AFFIRMED.

Your case is RETURNED to NYSOH to redetermine you and your spouse's eligibility for financial assistance on a monthly basis as of your December 26, 2017 application for health insurance. NYSOH is directed to determine your and your spouse's eligibility based on a household of two people, residing in Suffolk County with a monthly income of \$957.16. Any redetermination made on the basis of this information is to be effective as if the determination was made on December 26, 2017.

How this Decision Affects Your Eligibility

NYSOH properly found you and your spouse eligible for the Essential Plan effective February 1, 2018.

Your case is being sent back to NYSOH to redetermine you and your spouse's eligibility based on the income documentation you submitted following your hearing.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
