## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective February 1, 2018?

## Procedural History

On December 27, 2017, you submitted an updated application for financial assistance to NYSOH. That day, a preliminary eligibility determination was prepared stating that you were eligible for Medicaid, effective December 1, 2017. You subsequently enrolled into a Medicaid Managed Care plan for a February 1, 2018 start date.

Also on December 27, 2017 you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Medicaid Managed Care plan, insofar as it did not begin January 1, 2018.

On December 28, 2017 NYSOH issued a notice of eligibility determination, based on your December 27, 2017 application, stating that you were eligible for Medicaid, effective December 1, 2017.

Also on December 28, 2017 NYSOH issued a notice of enrollment in the plan you selected on December 27, 2017, stating that you were enrolled in a Medicaid Managed Care plan, and that your coverage would start on February 1, 2018.

On February 13, 2018 you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and the record was left open until February 20, 2018 to allow you time to submit additional documents.

As of February 20, 2018, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you first applied for health coverage on December 12, 2017.
- 2) You testified that you received assistance filing an application at your [REDACTED] and were not sure if you applied for health insurance through NYSOH or your local Department of Social Services but that the application was for Medicaid.
- 3) You testified that you received a notice regarding your December 12, 2017 application but you were not sure if that notice was from the local Department of Social Services or NYSOH. The record was left open until February 20, 2017 to allow you time to upload a copy of the notice.
- 4) Your NYSOH online account reflects that you submitted an application for financial assistance to NYSOH on December 27, 2017.
- 5) There is no evidence contained in your NYSOH account that any application was filed with NYSOH prior to December 27, 2017.
- 6) You testified, and the record reflects, that you selected your Medicaid Managed Care Plan through NYSOH on December 27, 2017, and that your enrollment was effective on February 1, 2018.
- 7) You testified that you want your Medicaid Managed Care plan to begin on January 1, 2018 because you initially applied for health insurance on December 12, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your enrollment in the Medicaid Managed Care plan was effective February 1, 2018.

The record reflects that you first contacted NYSOH on December 27, 2017 and filed an application for health insurance on that day.

Although you testified that you initially applied for health insurance online with the assistance of a representative from your [REDACTED] on December 12, 2017, you were unsure of whether this application was with your local Department of Social Services or NYSOH. There is no evidence of a December 12, 2017 application in your NYSOH account and you did not upload any documentation by the February 20, 2018 deadline showing that you applied for health insurance through NYSOH on December 12, 2017.

Therefore, your account reflects that the first application you submitted for the month of December with NYSOH was on December 27, 2017. Also on December 27, 2017, you selected a Medicaid Managed Care plan for enrollment.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On December 27, 2017, you selected a Medicaid Managed Care plan, so it properly took effect on the first day of the second month following after December 2017; that is, on February 1, 2018.

Therefore, the December 28, 2017 enrollment confirmation notice stating that your enrollment in your Medicaid Managed Care plan would be effective February 1, 2018, was correct and must be AFFIRMED.

## **Decision**

The December 28, 2017 enrollment confirmation notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your eligibility.

The effective date of your Medicaid Managed Care plan is February 1, 2018.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
