On December 30, 2017, NY State of Health (NYSOH) issued an enrollment confirmation notice, stating that you were enrolled in an Essential Plan, effective February 1, 2018. You appealed that determination.

On February 1, 2018, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath. During the hearing, you authorized [REDACTED] to act as your Authorized Representative and to assist with your testimony. Your Authorized Representative was placed under oath.

While under oath, your Authorized Representative testified that you no longer required an appeal on the start date of your Essential Plan because the month in question had already passed and you had submitted an application for Medicaid.

Your Authorized Representative therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
